SPECIAL ROADS ACT, 1949 THE HARTHILL BYPASS SPECIAL ROAD

THE Secretary of State gives notice that he proposes to make the following Schemes and Order:

- 1. Two Schemes under sections 1, 2 and 9 of the Special Roads Act, 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, the effect of which will be:
 - (a) (i) to provide for a special road to bypass Harthill commencing from a point on the Edinburgh-Glasgow Trunk Road (A.8) 35 yards or thereby west of its junction with the Whitburn-Armadale Road (A.706), near Whitburn, in the County of West Lothian and proceeding in a general westerly direction to a point on the said trunk road 400

- yards or thereby west of its junction with the Shotts Ironworks Highway (B.7057) near Blairmains in the County of Lanark for the exclusive use of traffic of Classes I and II set out in Schedule 2 to the said Act; and
- (ii) to provide that the special road, except where it incorporates lengths of the Edinburgh-Glasgow Trunk Road A.8, shall become a trunk road on the date of coming into operation of the Scheme;
- (b) (i) to provide for two special roads near Hirst Lodge in the County of Lanark for the exclusive use of traffic of Cla ses I and II set out in Schedule 2 to the said Act, to connect the Harthill Bypass Special Road and the new road near Hirst Lodge in the County of Lanark to be provided in pursuance of that part of the draft Order described in paragraph 2(b) below; and
 - (ii) to provide that the special roads shall become trunk roads on the date of coming into operation of the Scheme.
- 2. An Order under sections 3 and 7 of the above Act as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, the effect of which will be:
 - (a) to provide for the improvement of 3 lengths of existing roads which will be affected by the construction of the Harthill Bypa s Special Road;
 - (b) to provide for the construction by the Secretary of State of 4 new roads for purposes connected with the con truction of the said special road, in substitution for lengths of existing roads authorised by the Order to be stopped up;
 - (c) to provide for the stopping up by the Secretary of State of two lengths of the Edinburgh-Glasgow Trunk Road (A.8) which enter the route of, or will be affected by the construction of, the said special road;
 - (d) to provide for the stopping up by the Secretary of State of 4 lengths of existing ide roads which cros or enter the route of, or will be affected by the construction of, the said special road;
 - (e) to provide for the construction of 6 new means of access to premises adjoining or adjacent to land comprised in the route of the said special road in substitution for lengths of private means of access to these premises authorised by the Order to be stopped up;
- (f) to provide for the stopping up of 13 private means of access to premises adjoining or adjacent to land comprised in the routes of the said special road after the new means of access have been opened for traffic;

- (g) to appropriate as part of the said special road two lengths of the Edinburgh-Glasgow Trunk Road (A.8) on the coming into operation of the Order; and
- (h) that the County Councils of the County of Lanark and the County of We t Lothian will become the highway authorities for the new roads in their respective areas on the sixteenth day of May next after the date on which notice is given by the Secretary of State to the e Councils that the said roads are opened for through traffic.
