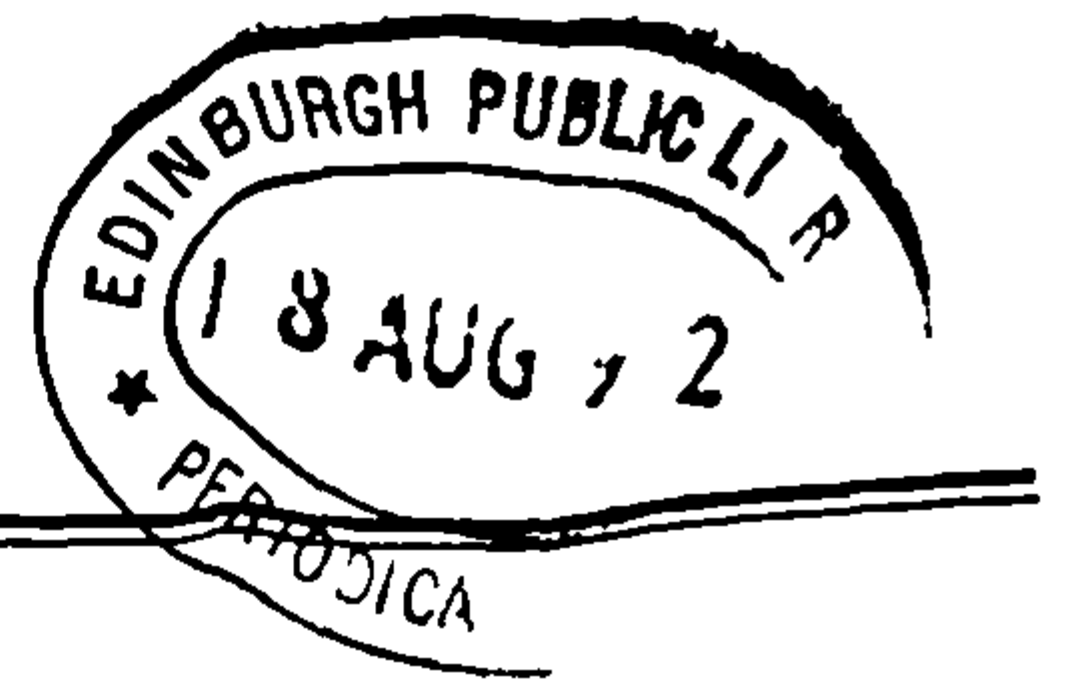

FACTORIES ACT 1961

IN pursuance of section 180 of, and Schedule 4 to, the Factories Act 1961 the Minister of Labour hereby gives notice that he proposes to make special regulations providing that for the purposes of the instruments specified in the Schedule to the regulations, the expression "factory" shall include the premises used for the slaughtering of animals or the confinement of animals while awaiting slaughter to which the definition of that expression in section 151 of the Factories Act 1937 (since repealed and re-enacted in section 175 of the Factories Act 1961) was extended by section 7 of the Slaughterhouses Act 1958 (since repealed and re-enacted in subsection 1 (d) and (e) of the said section 175).
