The Queen has been pleased by Warrant under Her Majesty's Royal Sign Manual, bearing date the 15th August 1962 to appoint Percy Wragg Brian, Esquire, Ph.D., Sc.D., F.R.S., to be Regius Professor of Botany in the University of Glasgow in place of Professor John Walton who will retire on 30th September 1962.

TRUNK ROADS ACT 1946 SPECIAL ROADS ACT 1949 WHITDALE CROSSROADS, HIRST LODGE SLIP ROADS

THE Secretary of State gives notice that he proposes to make the following Orders:

- 1. An Order under section 1 of the Trunk Roads Act 1946 as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955 the effect of which will be that
 - (a) a diversion which he proposes to construct and a length of the existing Whitburn-Armadale Road (A.706), at Whitdale Crossroads in the County of West Lothian and two new slip roads near Hirst Lodge in the County of Lanark to be constructed in pursuance of the proposed Harthill Bypass Special Road (Improvements) Order will become trunk roads on the date when the Order comes into operation;
 - (b) on the 16th May next after the date on which notice is given by the Secretary of State that the special road to be provided in pursuance of the proposed Harthill Bypass Special Road Scheme is opened for purposes of through traffic, the superseded length of the existing Edinburgh-Glasgow Trunk Road (A.8), the new diversion and the length of the existing Whitburn-Armadale Road will cease to be trunk roads and the County Councils of West Lothian and Lanark will become the highway authorities responsible for those lengths in their respective areas, and
 - (c) the Edinburgh-Glasgow Trunk Road (Harthill By-pass) Order 1955, will be revoked.
- 2. An Order under section 14 of the Special Roads Act 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955 to provide for the stopping up of a

length of the Edinburgh-Glasgow Trunk Road (A.8) when the new diversion to be provided at Whitdale Crossroads is opened for the purposes of through traffic.
