TRUNK ROADS ACT 1946 STONIE'S BRIDGE DIVERSION

THE Secretary of State gives notice that he has made an Order under Section 1 of the Trunk Roads Act 1946 as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955, the effect of which is that a diversion of the Perth-Aberdeen-Inverness Trunk Road (A.98) which he proposes to construct at Stonie's Bridge between Cullen and Fochabers in the County of Banff will become a trunk road on the date when the Order comes into operation, and that that length of the existing trunk road to be superseded thereby will cease to be a trunk road on the 16th May next after the date on which notice is given by the Secretary of State to the Banff County Council (who will thereafter become the highway authority responsible for that length) that the said diversion is opened for through traffic.

Copies of the Order, the title of which is "The Perth-Aberdeen-Inverness Trunk Road (Stonie's Bridge Diversion) Order 1962" can be purchased, price 3d., through any bookseller or direct from Her Majesty's Stationery Office, 13a Castle Street, Edinburgh 2.

Any Person aggrieved by the Order and desiring to question the validity thereof or of any provision contained therein on the grounds that it is not within the statutory powers or on the ground that any requirement of the said Act of 1946 or of regulations made thereunder, has not been complied with in relation to the Order, may, within six weeks of 14th September 1962, apply to the Court of Session for the suspension or quashing of the Order or of any provision contained therein.

PROHIBITION AND RESTRICTION OF TRAFFIC IN LANARK

SCHEDULE

The Orders would impose waiting restrictions and prohibit through south-going traffic on lengths of the Abington-Lanark-Airdrie-Cumbernuld Trunk Road (Route A.73) in the Burgh of Lanark as follows:

- (a) between the hours of 10 a.m. and 6 p.m.—Mondays to Saturdays inclusive—waiting would be prohibited on Bloomgate between its junctions with Broomgate and Wellgate and on the south side of Wellgate, Wellgatehead and Hyndford Road between its junctions with Bloomgate and Ladyacre Road, and on Bloomgate between its junctions with Broomgate and North Vennel there would be unilateral waiting with waiting limited to 30 minutes in any hour on that side of the road on which waiting was not for the time being prohibited; and
- (b) traffic proceeding from Bloomgate, High Street, Castle-gate or Hyndford Place to Hyndford Road south of its junction with Ladyacre Road would be prohibited from using Wellgate, Wellgatehead or Hyndford Road north of its junction with Ladyacre Road.

Exceptions would be provided in the Order prescribing the waiting restrictions to enable a vehicle to wait for so long as might be necessary for a person to board or alight to enable goods to be loaded or unloaded and to enable a vehicle to be used in connection with building operations or demolitions, etc. Provision would be made in the Order prohibiting the use of roads by through south-going traffic so that it would not apply to vehicles conveying persons, goods or merchandise to or from any premises on or adjacent to the roads or to vehicles being used in connection with any building operations or demolitions, etc.

Extension of Burgh Boundary and Redivision into Wards

A PETITION has been Presented in the Sheriff Court of Renfrew and Argyll at Paisley by the Provost, Magistrates and Councillors of the Burgh of Johnstone, Petitioners, against the County Council of the County of Renfrew, Respondents, wherein the Petitioners crave the Court—

- To take the necessary steps for extending the Boundary of the Burgh of Johnstone and to extend the same so as to include therein the following area extending to 210 acres or thereby all as shown on the Ordnance Survey Map produced therewith, videlicet: Commencing at point on the existing Burgh Boundary marked "A" on the said Map and extending southwards in a straight line for a distance of 1570 feet 6 inches or thereby across enclosures Nos. 170, 173, 171, 172 and 175(a) and across Auchengreoch Road to point marked "B" on the south side of said Auchengreoch Road and shown as Boundary Stone on said Map; thence westwards following the boundary line separating the Parishes of Paisley and Lochwinnoch to point where said boundary line crosses the south side of said Auchengreoch Road, thence continuing westwards on south side of said Auchengreoch Road to point marked "C" on said Map; thence south westwards in a straight line following a fence separating enclosures Nos. 1397 and 1400 for a distance of 600 feet or thereby to point marked "D" where said fence meets the north eastern side of a proposed Bypass road as shown on said Map; thence north westwards following the eastern boundary of said proposed Bypass road across enclosure No. 1400, across the road leading to Whitehill (enclosure No. 1399), across enclosures Nos. 1419, 1418, 1625, 1627, across the road leading from Auchengreoch Road to Howwood running parallel to the main Johnstone to Beith Highway and across enclosures Nos. 1659 and 1656 for a distance of 4020 feet or thereby to point marked "E" on said Map where said proposed Bypass road meets the south east side of the said Highway; thence north eastwards following the south east boundary of said Highway for a distance of 600 feet or thereby to point marked "F" on said Map situated at north western corner of enclosure No. 1661; thence north westwards across said Highway and following the north east boundary of roadway at Little Corseford to point marked "G" on said Map where said roadway meets the south eastern boundary of the Railway line leading from Johnstone to Glengarnock; thence north eastwards following the south eastern boundary of said Railway line to point marked "H" on said Map where said Railway line meets the existing Burgh Boundary at Cochranemill Road; thence generally in a southerly easterly direction along the existing Burgh Boundary to the point of commencement marked "A" on said Map; All as the said boundaries are shown coloured red and green on the said Map, the red lines defining the existing Burgh Boundary and the green lines the proposed extension of the same; or to do otherwise as the Court may think fit;
 - Subject to the above being granted, to alter the arrangement of the Third and Fourth Wards of the said Burgh of Johnstone, (allowing the arrangement of the First and Second Wards to be as set out in the Johnstone Wards Order hereinafter referred to) by adding to the Third Ward such part of the aforementioned area of ground as may lie to the south east of the main Johnstone to Beith Highway, and to the Fourth Ward such part of the aforementioned area of ground as may lie to the north west of said Highway.
- And whereas by the said Johnstone Wards Order made by the Secretary of State for Scotland on 4th August 1961 (as per Appendix 1 thereto) certain alterations were made in the Boundaries of the Four Wards and whereas it was ordered that all members of the Town Council retire on the day of the ordinary election on 1st May 1962 and that a new Council be elected and this has been done; Therefore the Petitioners ask the Court to declare that the Councillors so elected for the Third and Fourth Wards of said Burgh shall be the Councillors for the said Wards as proposed herein and on conditions

of retiral as have resulted from said Election ; Or to do otherwise as the Court may think fit.

The following Deliverance has been issued on said Petition, videlicet :

The Sheriff having considered the foregoing Petition Appoints the Petitioners to serve a copy of the Petition and of this Deliverance upon the Respondents The County Council of the County of Renfrew, County Buildings, Paisley, further Appoints them to give intimation of the import of the Petition and of this Deliverance by advertisement once in each of *The Edinburgh Gazette*, *The Glasgow Herald* and *The Paisley and Renfrewshire Gazette* Newspapers (embracing in said intimation the description of the proposed extended boundaries), and appoints all persons who have an interest and desire to be heard, to lodge a note of their objections with the Sheriff Clerk at Paisley, within fourteen days from the date of such service or intimation: Directs the said Petition and the Map produced therewith to lie meantime at the office of the Sheriff Clerk at Paisley for inspection by all parties interested."
