

Reserve No. 1 Declaration, 1962, the Beinn Eighe Nature Reserve No. 2 Declaration, 1962, the Inverpolly Nature Reserve No. 2 Declaration, 1962, the Loch Druidibeg Nature Reserve No. 2 Declaration, 1962, and the Tentsmuir Point Nature Reserve No. 2 Declaration, 1962, all made on the 28th day of September 1962, it was declared by the Nature Conservancy that the lands (First) (Second) and (Fourth) and part (One) of the lands (Fifth) hereinafter mentioned are now the subjects of Agreements entered into with them under the provisions of the Act, and that the land (Third) and parts (Two) and (Three) of the lands (Fifth) hereinafter mentioned have been acquired and are being held by them, namely:

- (First) Lands extending to 227 acres or thereby partly in the Parish of St. Cyrus and County of Kincardine and partly in the Parish of Montrose and County of Angus as shown enclosed within a red line, and partly tinted pink and partly tinted green on the map attached to the St. Cyrus Nature Reserve No. 1 Declaration, 1962.
- (Second) Land extending to 57 acres or thereby part of the Estate of Kinlochewe in the Parish of Gairloch and County of Ross and Cromarty, as shown tinted pink on the map attached to the Beinn Eighe Nature Reserve No. 2 Declaration, 1962.
- (Third) Land extending to 36 acres or thereby at Knockan Cliff forming part of the Farm of Langwell in the Parish of Lochbroom and County of Ross and Cromarty, as shown tinted pink on the map attached to the Inverpolly Nature Reserve No. 2 Declaration, 1962.
- (Fourth) Land extending to 1568 acres or thereby in the Island and Parish of South Uist and County of Inverness, as shown tinted pink on the map attached to the Loch Druidibeg Nature Reserve No. 2 Declaration, 1962.
- (Fifth) (One) Lands consisting of a portion of foreshore extending to 948 acres or thereby near Tentsmuir Point in the Parishes of Ferry Port on Craig and Leuchars and County of Fife as shown tinted blue on the map attached to the Tentsmuir Point Nature Reserve No. 2 Declaration, 1962.  
(Two) Lands extending to 173 acres or thereby near Tentsmuir Point in the last mentioned Parishes and County as shown tinted pink on the last mentioned map.  
(Three) Two pieces of land extending in all to 36 acres or thereby near Tentsmuir Point in the last mentioned Parishes and County as shown tinted green on the last mentioned map.

And it was further declared that the Lands (First) above mentioned are being managed as a nature reserve and the other Lands above mentioned are being managed as parts of nature reserves.
