lengths of the Abington-Lanark-Airdrie-Cumbernauld Trunk Road (Route A.73) in the Burgh of Lanark as follows:

- (a) between the hours of 10 a.m. and 6 p.m.—Mondays to Saturdays inclusive—waiting will be prohibited on Bloomgate between its junctions with Broomgate and High Street and on the south side of Wellgate, Wellgatehead and Hyndford Road between its junctions with Bloomgate and Ladyacre Road, and on Bloomgate between its junctions with Broomgate and North Vennel there will be unilateral waiting with waiting limited to 30 minutes in any hour on that side of the road on which waiting is not for the time being prohibited; and
- (b) traffic proceeding from Bloomgate, High Street, Castlegate or Hyndford Place to Hyndford Road south of its junction with Ladyacre Road will be prohibited from using Wellgate, Wellgatehead or Hyndford Road north of its junction with Ladyacre Road.

Exceptions are provided in the Order prescribing the waiting restrictions to enable a vehicle to wait for so long as might be necessary for a person to board or alight, to enable goods to be loaded or unloaded and to enable a vehicle to be used in connection with building operations or demolitions, etc. Provision is made in the Order prohibiting the use of roads by through south-going traffic so that it does not apply to vehicles conveying persons, goods or merchandise to or from any premises on or adjacent to the roads or to vehicles being used in connection with any building operations or demolitions, etc.

CLEAN AIR ACT, 1956 GLASGOW SHETTLESTON & TOLLCROSS SMOKE CONTROL AREA ORDER, 1963

1. NOTICE is hereby given that the Corporation of the City of Glasgow in exercise of the powers conferred on them by section 11 of the above mentioned Act on the second day of May 1963 made an order entitled "The Glasgow Shettleston & Tollcross Smoke Control Area Order, 1963" declaring the area described in the schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State for Scotland for confirmation.

2. Subject to the exemptions provided by the Order and by virtue of section 11(4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the course of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals. 3.
