Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

FACTORIES ACT 1961

IN pursuance of section 180 of, and Schedule 4 to, the Factories Act 1961, the Minister of Labour hereby gives notice that he proposes to make special regulations under section 33(2) and (3) of that Act. The proposed regulations prescribe the manner in which, and the occasions on which, steam boilers in factories and other places to which the Factories Act 1961 applies are required to be examined in pursuance of sections 33(2) and (3). ROAD TRAFFIC ACT 1960

*Argyll County Council (River Leven) Flood Prevention
Scheme 1963*

- (d) to enable the vehicle, if it cannot conveniently be used for such purpose in any other street, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the streets concerned, or the laying, erection, alteration or repair in or near to the said streets of any sewer, or of any water main or apparatus for the supply of gas, water or electricity, or of any telegraph line as defined in the Telegraph Act, 1878.

- (e) to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said street.
