## TEMPORARY TRAFFIC PROHIBITION

THE Secretary of State hereby gives notice that he proposes to make an Order under section 36 (1) of the Road Traffic Act 1960, prohibiting as from 8 a.m. on Monday, 29th July 1963, the use by vehicles which, laden or unladen, are more than 36 feet long, 8 feet 6 inches wide or 13 feet 9 inches high, of that length of the London-Edinburgh-Thurso Trunk Road (Route A.9) south of Dunkeld in the County of Perth which passes under Rohallion Railway Bridge until works of repair to the said bridge have been completed. It is expected that the works will last for approximately three weeks.

The alternative routes are:

- (a) at Ordie Bridge via Route B.9099 through Stanley to Caputh thence via Route A.984 to rejoin Route A.9 at Dunkeld and vice versa; and
- (b) at Stare Dam eastwards via the unclassified road to join Route B.9099 north of Murthly thence via Route B.9099 to Caputh and via Route A.984 to rejoin Route A.9 at Dunkeld and vice versa.

Between 9 a.m. and 6 p.m. Mondays to Saturdays including waiting would be prohibited in Murray Street (Route A.92), Montrose between its junctions with Victoria Street and High Street and in High Street (Route A.92) southwards from its junction with Murray Street for a distance of 33

The Order prohibits (1) the waiting of vehicles on (a) both sides of Muir Street, Motherwell—from its junction with Hamilton Road to its junction with Hope Street; (b) both sides of Merry Street, Motherwell—from its junction with Brandon Street to its junction with Pollock Street; (c) both sides of Brandon Street, Motherwell—from its junction with Hamilton Road to its north westerly junction with Melville Drive; (d) both sides of Hamilton Road, Motherwell—from its junction with Brandon Street to its junction with High Road; (e) both sides of Hill Street, Wishaw—from its junction with Main Street to its junction with West Thornlie Street, and (f) both sides of Russell Street, Wishaw—from its junction with Main Street to its junction with West Thornlie Street, except upon the direction or with the permission of a police constable in uniform between the hours of 11 a.m. and 5 p.m. on any day from Monday to Friday inclusive, or between the hours of 10 a.m. and 5 p.m. on any Saturday; (2) the waiting of vehicles as aforesaid on

alternative sides of the following streets, viz.: (a) Brandon Street, Motherwell—from its north-westerly junction with Melville Drive to its junction with Windmillhill Street; (b) Windmillhill Street, Motherwell—from its junction with Brandon Street to its junction with Crosshill Street; (c) Merry Street, Motherwell—from its junction with Pollock Street to its junction with Dalziel Street; (d) Kirk Road, Wishaw—from its junction with Stewarton Street to its junction with Campbell Street; (e) Caledonian Road, Wishaw—from its junction with Stewarton Street to its junction with Steel Street; (f) Stewarton Street, Wishaw—from its junction with Caledonian Road to its junction with Graham Street, and (g) Main Street, Wishaw—from its junction with Kirk Road to its junction with Glen Road, on days of the month which bear even and odd numbers, respectively, and (3) the waiting of vehicles as aforesaid in various streets for a period longer than twenty minutes. Provision is, however, made in the Order permitting a vehicle to wait in any of the lengths of road above specified for so long as may be necessary, to enable a person to board or alight from the vehicle, to enable goods to be loaded or unloaded from the vehicle, or to enable the vehicle to be used in connection with any funeral, building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road, in the laying of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or any telegraph line.

The Order comes into operation on 1st September 1963 and the Burgh of Motherwell and Wishaw (Various Streets) (Restrictions on Waiting) Order, 1960, made and enacted by the Town Council on the Fourth day of October 1960 is revoked as from that date.
