The QUEEN'S Most Excellent Majesty in Council

Whereas there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 16th day of December 1963 (MAN 735/1/63) in the words following, viz.:

"Whereas by section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay and pensions or other allowances in the nature thereof, payable in respect of Your Majesty's Naval or Marine Forces to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council;

"And whereas we are of the opinion that the more sophisticated messing procedures now being increasingly applied throughout Your Majesty's Fleet necessitate the institution of a Caterer Branch; and that consequent on the introduction of such a Branch we are of the opinion that a re-organisation of the Stores Branch procedures will lead to economies;

"We humbly beg leave to recommend that Your Majesty may be graciously pleased by your Order in Council to sanction the introduction of the following ratings to be paid the normal rates of pay and allowances applicable to naval ratings, namely

"Caterer Branch

Chief Petty Officer Caterer Petty Officer Caterer

"and

"Stores Accountant Branch

Chief Petty Officer Stores Accountant
Petty Officer Stores Accountant
Leading Stores Accountant
Stores Accountant
Probationary Stores Accountant
Junior Stores Accountant.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals."

Her Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of Her Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WAGES COUNCILS ACT 1959 RUBBER PROOFED GARMENT MAKING INDUSTRY WAGES COUNCIL

MINISTRY OF POWER MINES AND QUARRIES ACT 1954 Draft Mines (Medical Examinations) Regulations 1964

THE Minister of Power in accordance with the provisions of Section 142 of, and Part I of the Second Schedule to, the

Mines and Quarries Act 1954 hereby gives notice that he proposes to make General Regulations under Sections 92, 141 and 143 of the Act, entitled the Mines (Medical Examinations) Regulations 1964.

The medical examination of young persons at coal and miscellaneous mines, at present, is governed, respectively, by the Coal Mines (Medical Examinations) Regulations 1956 and regulation 70 of the Miscellaneous Mines General) Regulations 1956. There are no regulations to provide for the medical examination of young persons at mines of stratified iron tone, shale or fireclay. The new Regulations, which will come into operation on 1st October 1964, will apply to all mines and will revoke and replace the Regulations now in force for coal and miscellaneous mines. The general object of the draft Regulations is to provide that young persons under 18 years of age must be medically examined on first taking up employment at a mine and re-examined at yearly intervals until they are 18.

SPECIAL ROADS ACT 1949 THE WEST OF HARTHILL TO NEWHOUSE SPECIAL ROAD

WESTERN AREA PART DEVELOPMENT PLAN
