

By virtue of Article 9(1) of the Live Poultry (Restrictions) Order 1957, m de under the Dise e of Animals Act 1950, whenever poultry or poultry care es are delivered to any premises, it is unlawful to move poultry from such premises until a period of 28 days has elapsed from the day on which the poultry or poultry c reases were so d livered. This Order, which c me into operation on 6th January 1964, exempts fr m Article 9(1) (he form of which i revied) the movem nt under licence of poultry from premi es from which the movement wou d without a licence, be unlawful under the Fowl P st Order of 1936 (as amended).

The Order also amends Article 12 of the 1957 Order, which prohibits the movement of poultry, d y-old chicks and hatching eggs into Scotland from any other part of Great Britain, so as to enable the Secretary of State to licence such movement subject to their being detained at a quarantine station and tested for disease under the supervision of a veterinary in pector; and subject to any other conditions which may be specified in the licence.
