TENDERS FOR TREASURY BILLS

1. TRUNK ROADS ACT 1946 BANAVIE LOCK DIVERSIONS

TRUNK ROADS ACT 1946 SPECIAL ROADS ACT 1949 IMPROVEMENTS AT BANAVIE LOCK DIVERSIONS

TRUNK ROADS ACT 1946 SPECIAL ROADS ACT 1949 RENFREW BYPASS

THE Secretary of State gives notice that he proposes to make the following scheme and order:

TRUNK ROADS ACT 1946 SPECIAL ROADS ACT 1949 NORTH OF RIGGEND TO EAST OF CONDORRAT DIVERSION IMPROVEMENTS

THE Secretary of State gives notice that he proposes to make the following orders:

SCHEDULE

The effect of the Order would be to introduce for an experimental period of three months the following traffic regulation measures:

1. One-way traffic in an easterly direction to be introduced in the portion of Sauchiehall Street between Renfield Street and Buchanan Street.
2. One-way traffic in a southerly direction to be introduced in the portion of Buchanan Street between Parliamentary Road and Bath Street.
3. "No Waiting" restrictions to be imposed in place of the existing "unilateral" waiting restrictions throughout West Nile Street between the hours of 8 a.m. and 6 p.m. on Mondays to Fridays inclusive and between the hours of 8 a.m. and 1 p.m. on Saturdays.
4. "No Waiting" restrictions to be imposed throughout Robertson Street and York Street between the hours of 8 a.m. and 6 p.m. on Mondays to Fridays inclusive and between the hours of 8 a.m. and 1 p.m. on Saturdays.
5. Vehicles not to be permitted to stand in any part of West Nile Street for the purpose of loading or unloading between the hours of 8.15 a.m. and 9.30 a.m. on Mondays to Saturdays inclusive and between the hours of 4.30 p.m. and 6 p.m. on Mondays to Fridays inclusive.
6. Minor modifications to be made in the siting of bus bays—
 - (a) on the south side of Bath Street opposite the King's Theatre;
 - (b) on the west side of Hope Street between Cowcaddens Street and Wemyss Street;
 - (c) on the north side of Sauchiehall Street between St. George's Road and Garnet Street; and
 - (d) on the north side of Sauchiehall Street between Cambridge Street and Hope Street.
7. The restrictions now applied at the more northerly of the two bus bays on the west side of Commerce Street between Wallace Street and Nelson Street to be removed.

LONDON ROAD—40 m.p.h. Speed Limit
