BURGH OF CLYDEBANK PART DEVELOPMENT PLAN No. 2

Proposed Developments at East Portion of Clydebank and South of Great Western Road, Clydebank

NOTICE is hereby given that the Town Council of the Burgh of Clydebank have considered proposed development the eastern portion of the Burgh and south of Great W ten Road, Clydebank, which will involve changes in z ning in the Burgh of Clydebank Part Development Plan No. 2.

The modifications involving the changes in zoning relate to the following areas of ground:—

(1) An area of ground extending to .68 acre situated on the north side of Glasgow Road to the east of Hamilton Street. The area forms part of an area zoned in the said Part Development Plan as residential. The pro-

- (5) Stationmaster's house, Yoker Station, and area of land extending to .21 acre on the west side of Yokermill Road zoned as Railway Lands in the said Part Development Plan. The proposed modification involves zoning as residential.
- (6) An area of ground extending to .459 acre situated on the south side of Great Western Road, Clydebank, being part of land owned by Clydebank Town Council. The area forms part of and area zoned in the said Part Development Plan as public open space. The proposed modification involves zoning as commercial.

The proposed modifications (1) to (5) supersede the modifications which were proposed in relation to the eastern portion of the Burgh and which were advertised in the issues of the Edinburgh Gazette, the Glasgow Herald and the Clydebank Press of 5th April 1963, and also in the issue of the Clydebank Press of 12th April 1963.
