TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 1st May 1964 at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £230,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 4th May 1964 to Saturday the 9th May 1964, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

Whereas Her Majesty has by Her Letters Patent dated the 16th day of March 1964 been pleased to revoke Her Letters Patent dated the 17th day of February 1964 constituting and appointing the persons therein named to be Her Commissioners for executing the Office of Her Lord High Admiral as therein mentioned during Her Pleasure;

And whereas it is expedient in consequence of the dissolution of Her Board of Admiralty to modify the Orders in Council hereinafter referred to, being Orders made under section 3 of the Naval and Marine Pay and Pensions Act 1865 (28 & 29 Vict. c. 63) or under that section as extended or applied by section 2 of the Naval Pensions Act 1884 (47 & 48 Vict. c. 44), section 1 of the Naval Forces (Enforcement of Maintenance Liabilities) Act 1947 (10 & 11 Geo. 6. c. 24) and section 1 of the Naval and Marine Reserves Pay Act 1957 (5 & 6 Eliz. 2. c. 32), and under other powers enabling Her Majesty in that behalf.

Now, therefore, Her Majesty, in pursuance of the powers aforesaid, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. In this Order references to the Commissioners are references to the Commissioners for executing the Office of the Lord High Admiral (however styled).

2. Any functions conferred on the Admiralty or the Commissioners by or under any Order in Council made under any of the said powers shall be transferred to the Secretary of State.

3. Subject to the provisions of Article 4 of this Order, for any reference to the Admiralty or the Commissioners contained in any Order in Council made under any of the said powers (whether that Order confers such functions as aforesaid or not) there shall (unless the context otherwise requires) be substituted a reference to the Secretary of State.

4. Each of the Orders in Council specified in column 1 of the Schedule to this Order shall have effect subject to the modifications specified opposite thereto in column 2 of the said Schedule.

5. Nothing in this Order shall invalidate anything done before the date of its coming into operation and anything which on that date is in process of being done by virtue of any such Order in Council as aforesaid by or in relation to the Admiralty or the Commissioners may be continued by or in relation to the Secretary of State.

6. Notwithstanding anything in this Order, any regulation, rule, direction, authority, appointment, authentication, approval or other instrument or act effective by virtue of any

such Order in Council as aforesaid at the date of the coming into operation of this Order as that of the Admiralty or the Commissioners shall continue to have effect as that of the Secretary of State.

7. This Order shall come into operation on 1st April 1964 and may be cited as the Naval and Marine Pay and Pensions (Transfer of Functions) Order 1964.
