PRIVY COUNCIL OFFICE Oil in Navigable Waters Act 1955

NOTICE is hereby given that Her Majesty in Council was pleased, on the 23rd June 1964, to approve an Order in Council under the above-named Act entitled "The Oil in Navigable Waters (Convention Countries) (Italian Republic) Order 1964. (S.I. 1964/931).

MINISTRY OF LABOUR

THE Minister of Labour hereby gives notice that on 25th June 1964 he made the Offices, Shops and Railway Premises Act 1963 (Exemption No. 1) Order 1964, exempting offices on sites of building operations or works of engineering construction from the requirements of section 6 (temperature) and section 10 (1) (provision of running water for washing) of the Offices, Shops and Railway Premises Act 1963. The exemption from section 6 is granted subject to the condition that employees are provided with conveniently accessible and effective means of warming themselves, and are given reasonable opportunities to use them. The means of warming must not give rise to injurious or offensive fumes.

THE Minister of Labour hereby gives notice that on 25th June 1964 he made the Sanitary Conveniences Regulations 1964 and the Washing Facilities Regulations 1964.

These regulations are made under sections 9 (3) and 10 (3) respectively of the Offices, Shops and Railway Premises Act 1963. They determine for premises to which the Act applies (other than premises aggregated in certain markets) what is suitable and sufficient provision of sanitary conveniences and washing facilities for the purposes of sections 9 (1) and 10 (1) respectively of the Act.

THE Minister of Labour hereby gives notice that on 25th June 1964 he made the Offices, Shops and Railway Premises First Aid Order 1964.

This Order prescribes, for the purposes of section 24 of the Offices, Shops and Railway Premises Act 1963, the first-aid requisites and appliances to be contained in first-aid

boxes and cupboards provided under that section in the case of office, shop and railway premises. The Order also prescribes the conditions which a person is required to satisfy before he is deemed to be trained in first-aid treatment for the purposes of section 24 of the Act.

THE Minister of Labour hereby gives notice that on 25th June 1964 he made the Prescribed Dangerous Machines Order 1964.

This Order prescribes for the purposes of section 19 of the Offices, Shops and Railway Premises Act 1963 a number of dangerous machines at which a person must not work unless he has been fully instructed as to the dangers arising and the precautions to be observed, and either has received a ufficient training in work at the machine or is under adequate supervision by a person who has thorough knowledge and experience of the machine.

DRAFT SPECIAL REGULATIONS OFFICES, SHOPS AND RAILWAY PREMISES ACT 1963

IN pursu nce of section 80 of, and Schedule 1 to, the Offices, Shops and Railway Premises Act 1963, the Minister of Labour hereby gives notice that he proposes to make special regulations under that Act imposing requirements about first aid in offices and shops in factories, and in offices in electrical stations and on construction sites.

These regulations will apply the first-aid provisions of the F ctories Act, with certain modifications, or the first-aid provisions of regulations made under the Factories Act, to the e classes of premises instead of section 24 (fir t aid) of the Offices, Shops and Railway Premises Act 1963.

The draft regulations are entitled the Offices and Shops in F ctories (First Aid) Regulations, the Offices in Electrical St tions (First Aid) Regulations and the Offices at Building Oper tions &c. (First Aid) Regulations and will be m de und r section 25, section 74 (2) and (3) and section 26 repectively of the Act. Copies of the draft regulations may b obtained from H.M. WAITING RESTRICTIONS—TRUNK ROADS A.85 AND A.816 IN OBAN

THE Secretary of State hereby gives notice that he has made an Order under section 26 of the Road Traffic Act 1960 the effect of which is set out in the Schedule hereto.

SCHEDULE

The Order revokes the Trunk Roads (George Street, Oban) (Prohibition of Waiting) Order, 1958 and prohibits waiting and imposes unilateral waiting restrictions on the fixed day system, between 8 a.m. and 8 p.m. Mondays to Saturdays inclusive, on lengths of the Tarbert-Inveraray-Lechgilphead-Oban Trunk Road (Route A.816) and the Tyndrum-Oban Trunk Road (Route A.85) in Oban in the County of Argyll as follows:

1. PACHISITION OF WAITING

Trunk Road A.816-

- a) between points 50 yards south and 16 yards north of its junction with Miller Road;
- (b) between points 10 yards south and 65 yards north of its junction with Glencruitten Road;
- (c) between a point 11 yards south of its junction with Stevenson Street and its junction with High Street.

Trunk Road A.85-

- a) between the south side of its junction with Airds Crescent and a point 20 yards north if its junction with Stevenson Street;
- b) between points 39 yards south and 7 yards north of its junction with Stafford Street;
- (c) between points 18 yards south and 121 yards north of its junction with Nursery Lane.

2. UNILATERAL WAITING

Trunk Road A.816-

- (2) between points 155 yards and 50 yards south of its junction with Miller Road;
- (b between points 16 yards north of its junction with Miller Road and 10 yards south of its junction with Glencruitten Road;
- c between points 65 yards north of its junction with Glencruitten Road and 11 yards south of its junction with Stevenson Street.

Trunk Road A.85-

- (a) between its junction with Argyll Square and the south side of its junction with Airds Crescent;
- (b) between points 20 yards north of its junction with Stevenson Street and 39 yards south of its junction with Stafford Street;
- (c) between points 7 yards north of its junction with Stafford Street and 18 yards south of its junction with Nursery Lane;
- (d) between points 83 yards north of its junction with Breadalbane Street and 40 yards south of its juncion with Corran Parks.

In the case of the unilateral lengths waiting is limited to 30 mms, in any hour on that side of the road on which vehicles are not prohibited from waiting for the time being. The Order provides for exceptions to enable a vehicle to wat for so long as may be necessary for a person to board or alight, to enable goods to be loaded or unloaded and to enable a vehicle to be used in connection with building operations or demolitions, etc.
