IRON AND STEEL ACT, 1953
Price Determination by the Iron and Steel Board

NOTICE Is Hereby Given that the Iron and Steel Board have, pursuant to section 8 of the Iron and Steel Act, 1953, by an instrument in writing which will be known as Iron and Steel Board Price Determination 1964, No. 4, varied the Iron and Steel Board Price Determinations 1964, Nos. 1, 2 and 3.

The new Determination, which comes into force on the 13th July 1964, amends the maximum prices which may be charged in the United Kingdom by iron and steel producers for Alloy and Stainless Steels containing molybdenum and/or vanadium. The changes reflect increased prices for ferro-molybdenum and lower prices for ferro-vanadium. Full details are given in the new Related Schedules as follows:
