TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 24th July 1964 at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £230,000,000.
2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 27th July 1964 to Saturday the 1st August 1964, inclusive, and will be due 91 days after date.
3. The Bills will be issued and paid at the Bank of England.
4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
5. Tenders must be made through a London Banker, Discount House or Broker.
6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.
7. Members of the House of Commons are not precluded from tendering for these Bills.
8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

SCHEDULE

The Order imposes the following waiting restriction, on an experimental basis, on lengths of High Street, Fort William, which forms part of the Glasgow-Fort William-Inverness Trunk Road A.82:—

1. Waiting will be limited to 30 minutes at all times, with no loading or unloading between the hours of 10 a.m. and 5 p.m., on the south east side between a point 80 yards east of Parade Road and the north-east side of Monsie Square and on the north-west side between Station Square and New Pier Lane ;
2. Waiting will be prohibited at all times, with no loading or unloading between the hours of 10 a.m. and 8 p.m. on both sides of the trunk road between Monsie Square and Gordon Square ;
3. Waiting, loading and unloading will be prohibited at all times on the north and north-west side from a point opposite Fassifern Road to Linnhe Road and from New Pier Lane to the exit from the car park ; on the south and south-east side from Fassifern Road to the entrance to Duncansburgh Church, and from Gordon Square to Lundavra Road.

The Order provides for exceptions to enable a vehicle to wait for so long as may be necessary for a person to board or alight and to enable a vehicle to be used in connection with building operations or demolitions, etc.

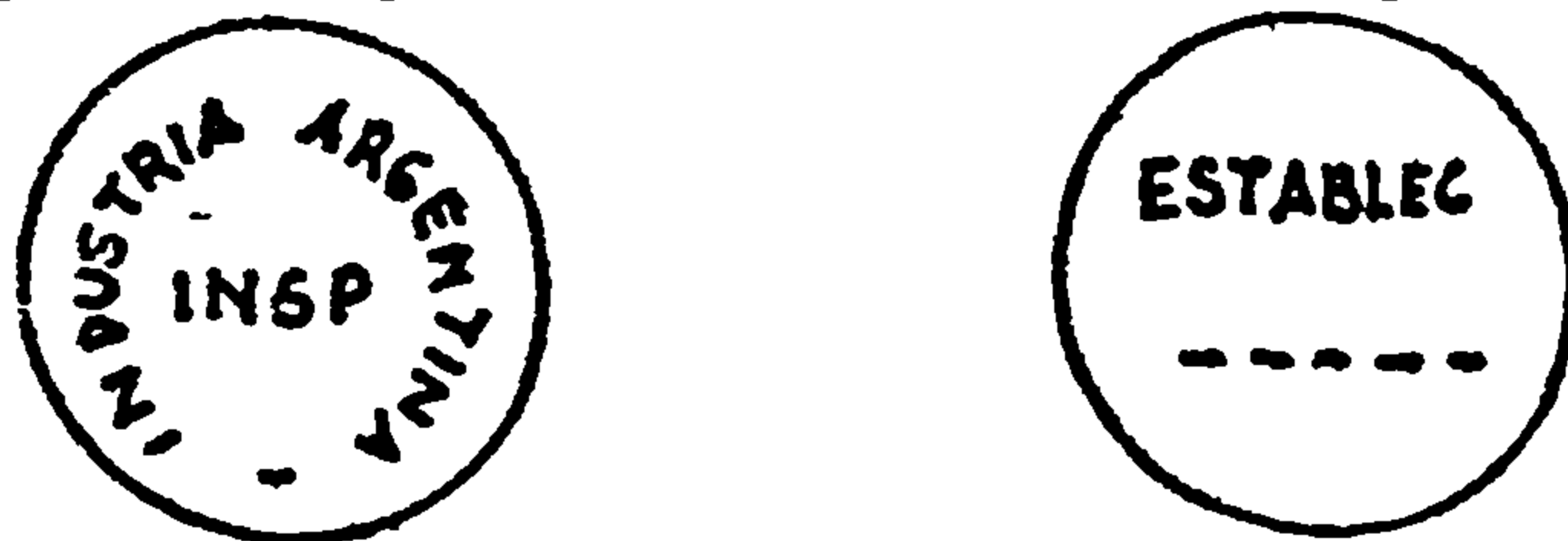

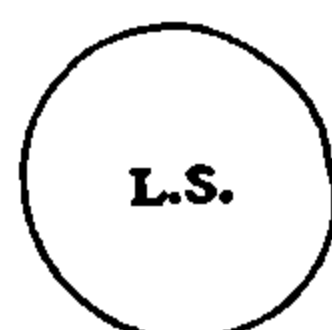

THE WAITING RESTRICTIONS—EAST HIGH STREET, HIGH STREET, WEST HIGH STREET and KING STREET, CRIEFF, ORDER 1964

ON the 13th July 1964, the Crieff Town Council made an Order under Section 26 of the Road Traffic Act 1960, which shall come into force on the 1st August 1964, the effect of which is set out in the Schedule hereto.

The effect of the Order is that on and from 1st August 1964, no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait in any of the following lengths of road in the Burgh of Crieff, except as stated, namely:—

1. *East High Street*
In East High Street from a point immediately west of its junction with Ramsay Street to a point immediately east of its junction with Mitchell Street, unilateral parking on alternate sides on alternate days will apply with a waiting period not exceeding 20 minutes at a time.

Otherwise there will be No Waiting in this section of East High Street.

2. High Street

In High Street from a point immediately west of its junction with The Cross to the east boundary of the British Linen Bank building parking on the north side only will apply with a waiting period not exceeding 20 minutes at a time. Otherwise there will be No Waiting in this section of High Street.

3. West High Street

In West High Street west from the east boundary of The Coffee Shop property to a point 5 yards immediately east of its junction with Galvelmore Street parking on the south side only will apply with a waiting period not exceeding 20 minutes at a time. Otherwise there will be No Waiting in any part of West High Street.

4. King Street

In King Street from a point immediately south of the entrance leading to the King Street car park to the north boundary of the lane or passage leading to Station Cottages, excluding the road junctions in this section, unilateral parking on alternate sides on alternate days will apply with a waiting period not exceeding 20 minutes at a time. Otherwise there will be No Waiting in this section of King Street.

The restrictions shall not apply

1. To any vehicle waiting for so long as necessary:—
 - (a) To enable any person to board or alight from the vehicle;
 - (b) To enable goods to be loaded on to or unloaded from the vehicle; or
 - (c) To enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition or excavation, the removal of any obstruction to traffic or the maintenance of the road in question or the services therein.
2. To fire engines, ambulances, disabled persons' vehicles, postal vehicles or funeral vehicles.
