SCHEDULE

The Order prohibits vehicles from waiting between 10 a.m. and 6 p.m. Mondays to Saturdays inclusive, on those lengths of the Gretna-Stranraer-Glasgow-Stirling Trunk Road (Route A.75) at Newton Stewart, in the County of Wigtown, which extend—

- (a) on the east side of Victoria Street from the Cree Bridge in a southerly direction for a distance of 85 feet;
- (b) on the west side of Victoria Street from its junction with Arthur Street in a southerly direction for a distance of 157 feet; and
- (c) on Alfred Place between its junction with Arthur Street and the Cree Bridge.
