THE RENFREW (No. 2) SMOKE CONTROL
AREA ORDER, 1965

1. NOTICE Is Hereby Given that the Provost, Magistrates and Councillors of the Royal Burgh of Renfrew in exercise of the powers conferred on them by Section 11 of the above-mentioned Act on the Eighteenth day of October 1965, made an Order entitled "The Renfrew (No. 2) Smoke Control Area Order 1965" declaring the Area described in the Schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for Scotland for confirmation.

2. Subject to the exemptions provided by the Order and by virtue of Section 11 (4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a

chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are: Anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals.

3. Copies of the Order and of the Map referred to therein may be inspected free of charge at the Town Clerk's Office, Monkdyke, Alexandra Drive, Renfrew, at all reasonable times during the period of six weeks from the First day of November 1965.
