TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 19th November 1965, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £180,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 22nd November 1965, to Saturday the 27th November 1965, inclusive, and will be due 91 days after date.

(3) The Interpretation Act 1889 (c) shall apply to the interpretation of this Act of Adjournal as it applies to the interpretation of an Act of Parliament.

2. (1) The endorsement of a warrant for execution within any part of Scotland in terms of section 1 of the Act shall be as nearly as possible in the form exemplified in Form 1 contained in the Schedule hereto.

(2) A provisional warrant issued under section 4 of the Act shall be as nearly as possible in the form exemplified in Form 2 contained in the Schedule hereto.

(3) Where a person has been remanded in custody in terns of section 21) or section 43) of the Act, the order of court shall be endorsed by the court on the warrant and delivered to the prison Governor to whose custody the person has been remanded.

(4) When a person who ha been ordered to be delivered in accordance with section 21) of the Act is remanded on bail, the bail bond shall require him to surrender at a specified police station at a time and date to be notified to him by or on behalf of the officer in charge of that station.

3. (1) A notice given under section 3(1)(a) of the Act (consent to removal earlier than is otherwise permitted) shall be as nearly as possible in the form exemplified in Form 3 contained in the Schedule hereto, and shall be signed in the presence of either a sheriff, a magistrate, a justice of the peace or a sheriff clerk who shall also sign the same.

(2) Any such notice given by a person who has been remanded in custody shall be delivered to the Governor of the prison in which he is detained.

ACT OF ADJOURNAL

Relative to the Backing of Warrants (Republic of Ireland)

At Edinburgh, the fifth day of November Nineteen Hundred and sixty-five

Present-

The Right Honourable The Lord Justice-General

(3) If a person remanded on bail gives such notice, he shall deliver or send it to the clerk of the court which so remanded him.

4. (1) When a person has been ordered to be delivered in accordance with section 2 1) of the Act, the sheriff clerk when the person is remanded on bail, or the Governor of the prison when the person is detained in custody, shall arrange for the warrant of arrest issued by a judicial authority in the Republic and endor d in accordance with section 1 of the Act to be given to the member of the police force of the Repu' lic in o v ho e custody the person is delivered when the person is so delivered.

(2) When the person ordered to be delivered in accordance with section 21) of the Act is remanded on bail, the sheriff clerk shall send a copy of the bail bond to the police station at which the person is to surrender.

5. (1) A document purporting to be a warrant issued by a judicial authority in the Republic shall, for the purpose of section 7(a) of the Act, be verified by a certificate purporting to be signed by a judicial authority, a clerk of a court or a member of the police force of the Republic and certifying that the document is a warrant and is issued by a court, judge or justice of a court or a peace commissioner.

(2) A document purporting to be a copy of a summons issued by a judicial authority in the Republic shall, for the purposes of the said section 7(a), be verified by a certificate purporting to be signed by a judicial authority, a clerk of a court or a member of the police force of the Republic and certifying that the document is a true copy of such a summons.

(3) A deposition purporting to have been made in the Republic, or affidavit or written statement purporting to have been sworn therein, shall, for the purposes of section 7(c)of the Act, be verified by a certificate purporting to be signed by the person before it was sworn and certifying that it was so sworn.

The Lord Justice-General, Lord Justice-Clerk and Lords Commissioners of Justiciary, by virtue of the powers conterred upon them by section 76 of the Summary Jurisdiction (Scotland) Act 1954 (a) and section 8 of the Backing of Warrants (Republic of Ireland) Act 1965 (b), and of all other powers competent to them in that behalf, do hereby enact and declare as follows:

1. (1) This Act of Adjournal may be cited as the Act of Adjournal (Backing of Warrants) (Republic of Ireland) 1965, and shall come into operation on 15th November 1965.

(2) In this Act of Adjournal the following expressions shall, unless the context otherwise requires, have the meanings hereby respectively assigned to them:

"the Act" means the Backing of Warrants (Republic of Ireland) Act 1965 (b);

"judicial authority" means a court, judge or justice of a court, or peace commissioner;

"the Republic" means the Republic of Ireland;

"sheriff clerk" includes sheriff clerk depute.
