TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 4th February 1966, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £150,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 7th February 1966, to Saturday the 12th February 1966, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

REFERENCE TO THE NATIONAL BOARD FOR PRICES AND INCOMES

COSTS PRICES AND PROFITS IN THE BREWING INDUSTRY

UNDER the arrangements for "early warning" of price increases, the Government have received advance notification from a number of brewers of their intention shortly to increase the wholesale price of certain of their beers.

The brewers concerned have made available to the Government information about the increases in costs, including labour costs, which they have incurred. The Government note that, while, apart from increases following duty changes, the prices of a number of beers which it is now proposed to increase have not been raised for some time, the prices of others were increased in the course of 1965. They consider that before further price increases take place as now proposed it would be in the national interest that the structure of costs and prices in the brewing industry and also the level of profits should first be examined by the National Board for Prices and Incomes.

The Board are requested to put the necessary enquiries in hand with a view to making their report (before the end of March 1966).
