**NEW ROAD BETWEEN DULOCH, FIFE AND  
BLAIRADAM, KINROSS-SHIRE**

THE Secretary of State gives notice that he has made the Crossgates, Cowdenbeath and Keltie Bypass—Stage II Special Road Scheme 1966 under sections 1, 2 and 9 of the Special Roads Act 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955, the effect of which is:
