PRESENT

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Secretary of State for Scotland has, in pursuance of the powers competent to him under the Burial Grounds (Scotland) Act 1855, made a Representation that he has received a copy of an Interlocutor dated 28th October 1965, pronounced by the Sheriff of Roxburgh, Berwick and Selkirk at Jedburgh, finding that the Burial Ground in the Parish of Kelso surrounding the Old Parish Church and bounded by Abbey Row, The Butts and The Knowes, in the County of Roxburgh, is in a condition which is offensive or contrary to decency:

And Whereas in the said Representation it is recommended that in terms of section 5 of the said Act burials be forthwith discontinued in the said Burial Ground except for the burial of:

- (1) any person whose husband or wife has been buried in the said Burial Ground;
- (2) any person whose child has been buried in the said Burial Ground;
- (3) any unmarried person who, at the date of the closure of the said Burial Ground, was over forty years of age and had at that date a parent buried in the said Burial Ground; and
- (4) cremated remains of any person who, but for the closure of the said Burial Ground, would be entitled to burial in a lair given off prior to the date of closure:

Provided always that such burials can be carried out without being dangerous to public health or offensive or contrary to decency and without interference with the remains of a previous burial, that proper and sufficient ground is available in the respective family burial grounds, that no such burial except the burial of cremated human remains shall be made unless the coffin can be laid at a depth of not less than four feet from the surface of the ground to the upper surface of the coffin, and that intimation be given to the Burial Grounds Officer of the County of Roxburgh not later than the day preceding that on which a grave is to be opened:

Now, therefore, Her Majesty is pleased, by and with the advice of Her Privy Council, to give Notice of the said Representation and to order that the same be taken into consideration on the 25th day of July next:

And Her Majesty is further pleased to direct that this

Order, or notice thereof, be published in the *Edinburgh Gazette* and that copies of this Order, or notice thereof, be fixed as required by the said Act on the doors of the Old Parish Church at Kelso, or on some other conspicuous places within the Parish of Kelso in the County of Roxburgh one month before such Representation is so considered.

Statutory Instruments 1966 No. 568

*The Importation of Horses, Asses and Mules (Amendment)
Order 1966*

(Made 12th May 1966)

This Order, which came into operation on 15th May 1966, prohibits the landing of horses in Great Britain from European countries without a licence from the Minister of Agriculture, Fisheries and Food or the Secretary of State for Scotland. A disease known as swamp fever, which has broken out in France, is believed to be infectious equine anaemia and the order is made to prevent the introduction of this latter disease into Great Britain. The prohibition, unless extended by a subsequent order, will be for a period of 6 months from 15th May 1966. Conditions may be imposed in licences, and contraventions can be enforced by prosecution of the offender and detention of the horse.

CORPORATION OF THE CITY OF DUNDEE

Road Traffic Act, 1960

The City of Dundee (Traffic Regulation No. 1) Order, 1966

ON the Second day of June, 1966 the Corporation of the City of Dundee made an Order under Sections 26 and 27 of the Road Traffic Act, the effect of which is:

- (a) To make permanent the Traffic Regulations relating to One-way streets and restrictions on waiting introduced by "The City of Dundee (Traffic Regulation) Experimental Order, 1964" as amended by "The City of Dundee (Traffic Regulation Amendment No. 1) Experimental Order, 1965," and
- (b) To consolidate in the Order the Traffic Regulations relating to One-way streets introduced by "The City of Dundee (Various Streets) (One-way Traffic) Order 1960" and "The City of Dundee (Various Streets) (One-way Traffic) Order, 1962."

More specifically the effects of the Order are:

- (1) To establish as One-way streets those lengths of road listed in column 1 of the First Schedule hereto, the direction in which traffic will be permitted to travel on those lengths of road being shown in column 2 of the said Schedule.
- (2) To prohibit waiting of vehicles (except as undernoted) at all times on those lengths of road specified in Part I of the Second Schedule hereto and to prohibit waiting of vehicles (except as undernoted) between 8 a.m. and 7 p.m. on those lengths of road specified in Part II of the Second Schedule.
- (3) To restrict waiting of vehicles between the hours of 8 a.m. and 7 p.m. to 30 minutes in any hour on those lengths of road specified in the Third Schedule hereto.
- (4) To revoke the Traffic Orders specified in the Fourth Schedule hereto.

Note—(a) Certain classes of vehicles will be exempted from those provisions of the Order which prohibit waiting at all times or restrict waiting to certain times of the day. The main exemptions relate to vehicles delivering, collecting, loading or unloading goods, merchandise, &c. Such vehicles will be permitted to wait for periods not exceeding thirty minutes in any one place subject to the proviso that no such exemption will be made between the hours of 8 a.m. to 9.30 a.m. and 4.30 p.m. to 6 p.m. unless the permission of the Chief Constable has been obtained twenty-four hours in advance. Other classes of vehicles exempted include ambulances, fire engines, police vehicles, post office vehicles, public service vehicles stopping at authorised stopping places and vehicles in actual use in connection with a funeral undertaking or a removal of furniture.
