TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 17th June 1966, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £190,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 20th June to Saturday the 25th June 1966, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

MINISTRY OF POWER

MINES AND QUARRIES ACT 1954

Draft Coal and Other Mines (Managers and Officials) (Variation) Regulations 1966

THE Minister of Power, in accordance with the provisions of Section 142 of the Mines and Quarries Act 1954, and of Part I of the Second Schedule thereto, hereby gives notice that he proposes to make General Regulations under Sections 141 and 143 of the Act which will be entitled "The Coal and Other Mines (Managers and Officials) (Variation) Regulations 1966."

These Regulations will apply to mines of coal, stratified ironstone, shale and fireclay. They will vary the Coal and Other Mines (Managers and Officials) Regulations 1956, as previously varied*, in the following respects:

- (1) They provide that deputies, underground officials superior to deputies but inferior to managers and under-managers, other persons who carry out pre-shift inspections, and persons appointed to carry out inspections of places in a mine not comprised in any deputy's district (all of whom are required to be qualified as deputies) must have a qualification which is valid with respect to the mine at which they are so appointed. The purpose of this variation is to enable the Minister to approve new Rules proposed by the Mining Qualifications Board which will introduce a written examination for applicants for a deputy's certificate valid for safety lamp coalmines. It will also provide for a limited deputy's certificate, valid only for mines of stratified ironstone, shale and fireclay, and for the few remaining naked light coalmines, for which the qualifications will be simply the existing oral and practical tests.
- (2) The different periods of practical experience as a deputy required under Regulation 7(b) of the 1956 Regulations before a qualification can be obtained for appointment as an underground official superior to a deputy and inferior to the manager or under-manager will now be one year in all cases.
