Mines and Quarries Act 1954

Draft Coal and Other Mines (Support) Regulations 1966

THE Minister of Power, in accordance with the provisions of Section 142 of, and Part I of Schedule 2 to, the Mines and Quarries Act 1954, hereby gives notice that he proposes to make General Regulations under Section 49, 54, 141 and 143 of the Act, entitled the Coal and Other Mines (Support) Regulations 1966.

These regulations will replace, with amendments, the Coal and Other Mines (Support) Regulations 1956; they will apply to mines of coal, shale and fireclay and will relate to the setting of supports, systematic support at faces and roadheads and miscellaneous matters.

These regulations introduce specific provisions regarding support at places where armoured conveyors are used and are designed to give statutory force to the best current practice at prop-free front faces. Regulation 12 requires the manager to specify in support rules for any face on which an armoured conveyor is used, the maximum intervals between props and between props and the face, subject to prescribed limits, and provides that on such faces all props used for systematic support must comply with a specification approved by the Minister. Support systems at faces where armoured conveyors are not used are dealt with in Regulation 13.

Major changes are also made in connection with the following matters. Regulations 10 and 15 deal with the setting and securing of arch girders and their use at roadheads. Regulation 16 deals with powered supports which must also be of approved types. Regulation 17 introduces the requirement that a roof newly exposed by ripping must be forthwith effectively supported. Regulation 21 deals with falls of roof or side. Further requirements have been included in this regulation for the prevention of an extension of a fall and action to be taken to ensure the safety of any person passing or working near the scene of the fall. Regulation 22 deals with the systematic use of packs for controlling movement of strata and requires that details of the system shall be specified in support rules. Regulation 23 permits supports to be withdrawn from the area in advance of the pack front provided no material for pack building is obtained from any place from which supports have been withdrawn and provided additional supports are set to prevent the roof breaking into the pack space.

BURGH OF ALLOA

Road Traffic Act, 1960

The Burgh of Alloa (Various Streets) (Prohibition of Waiting) Order 1966

ON the Thirteenth day of June Nineteen Hundred and Sixty-six the Town Council of the Burgh of Alloa made an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which is set out in the Schedule hereto.

SCHEDULE

1. The Order may be cited as the Burgh of Alloa (Various Streets) (Prohibition of Waiting) Order, 1966, and shall come into operation on the Twenty-sixth day of September 1966.

- 2. Save as provided in Paragraphs 5 and 6 of this Schedule, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait in any of the lengths of roads specified in Appendix I hereto.
- 3. Save as provided in Paragraphs 5 and 6 of this Schedule, no person shall except as aforesaid, cause or permit any vehicle to wait between 8 a.m. and 6 p.m. on Mondays to Saturdays in any of the lengths of roads specified in Appendix II hereto.
- 4. Save as provided in Paragraphs 5 and 6 of this Schedule, no person shall, except as aforesaid, cause or permit any vehicle to wait between 8 a.m. and 6 p.m. on Mondays to Saturdays in any of the lengths of roads specified in Appendix III hereto for longer than 30 minutes or if a period of less than 30 minutes has elapsed since the termination of the last period of waiting (if any).
- 5. Nothing in Paragraphs 2, 3 and 4 of this Schedule shall prevent any person from causing or permitting a vehicle to wait in the lengths of road specified as aforesaid for so long as may be necessary—
 - (a) to enable a person to board or alight from the vehicle;
 - (b) to enable goods to be loaded on to or unloaded from the vehicle;
 - (c) to enable the vehicle, if it cannot be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of roads so specified, or the laying, erection, alteration or repair in or near to any of the said lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraph line as defined in the Telegraph Act, 1878; and
 - (d) to enable the vehicle, if owned by a funeral director or owner of funeral vehicles to be used in connection with a funeral but only on occasions when it cannot conveniently be used for such purpose in any other road.
- 6. Nothing in Paragraphs 2, 3 and 4 of this Schedule shall prevent any registered disabled person who is the owner and driver of a disabled person's vehicle on which is exhibited the appropriate disc issued by the Town Council from causing or permitting such vehicle to wait in the said lengths of road.
- 7. The Burgh of Alloa (Mill Street, High Street and Mar Street) (Prohibition of Waiting) Order 1961 and the Burgh of Alloa (Mill Street) (Unilateral Waiting) Order 1961 are hereby revoked.

APPENDIX I

Lengths of Roads in the Burgh of Alloa

Junction Place and Old Bridge Street

Southwards from a point in Junction Place at its junction with Mill Street to the junction of Old Bridge Street and Old High Street, a distance of 310 feet or thereby.

Mill Road

Eastwards from a point in Mill Road at its junction with Junction Place for a distance of 250 feet or thereby.

APPENDIX II

Primrose Street

West side-

(First) Southwards from its junction with Station Square for 40 feet or thereby; (Second) Southwards from a point 89 feet or thereby south of said junction for 10 feet or thereby; and (Third) Northwards from its junction with Drysdale Street for 55 feet or thereby.

Southwards from its junction with Station Square to its junction with Drysdale Street, a distance of 410 feet or thereby.

(First) Southwards from its junction with Drysdale Street for 42 feet or thereby; and (Second) Northwards from its junction with Mill Street for 125 feet or thereby.

(First) The east side of Mar Place northwestwards from its junction with Drysdale Street for 105 feet or thereby; (Second) the west side of Mar Place from a point 36 feet or thereby to the southeast of the boundary between 1 and 3 Mar Place southeastwards then southwards then southwards to a point on the north side of Marshill in a curve for 87 feet or thereby; and (Third) the south side of Marshill westwards from its junction with Mar Street for 195 feet or thereby.

(First) Southeastwards from its junction with Drysdale Street for 75 feet or thereby; (Second) Southeastwards from a point 124 feet or thereby southeast of its junction with Drysdale Street for 30 feet or thereby; (Third) Southeastwards from a point 216 feet or thereby southeast of its junction with Drysdale Street for 60 feet or thereby; and (Fourth) Northwestwards from its junction with Mill Street for 55 feet or thereby.

Candleriggs

Southwest side—

Southeastwards from its junction with Mill Street to its junction with Greenside Street, a distance of 430 feet or thereby.

Northeast side—

(First) Southeastwards from its junction with Mill Street for 40 feet or thereby; (Second) Southeastwards from a point 157 feet or thereby southeast of said junction for 73 feet or thereby; and (Third) Northwards from its junction with Greenside Street for 40 feet or thereby.

West Vennel and East Vennel

Westwards and eastwards respectively from their junctions with Candleriggs for 30 feet or thereby in each said direction.

Greenside Street

North side—

Eastwards from its junction with Candleriggs for 100 feet or thereby.

Shillinghill

Northwest side—

Northeastwards from its junction with Drysdale Street for 485 feet or thereby.

Southeast side—

(First) Northeastwards from its junction with Junction Place for 115 feet or thereby; and (Second) Northeastwards from a point 179 feet or thereby northeast of said junction for 60 feet or thereby.

King Street

Northwestwards from its junction with Shillinghill for 56 feet or thereby.

Mill Street

Northwest side—

(First) Northeastwards from its junction with Bank Street to a point 40 feet or thereby northeast of its junction with High Street, a disance of 465 feet or thereby; and (Second) Southwestwards from its junction with Drysdale Street for 40 feet or thereby.

Southeast side—

Provision of Parking Places

NOTICE Is Hereby Given That the Corporation of the City of Glasgow are applying to the Secretary of State for an Order under the Road Traffic Act 1960 as amended and extended by the Road Traffic and Roads Improvement Act 1960 and the Road Traffic Act 1962. The general effect of the proposed Order is to amend the Parking Places and Restriction of Waiting and Loading (Glasgow) Order 1965 by providing:

- (i) that the provisions of the Order should cease to have effect between the hours of 1 p.m. and 6 p.m. on Saturdays;
- (ii) that the restrictions on waiting applicable to the streets

described in Part I of Schedule 1 to the Order shall apply to the portion of Holland Street between West George Street and St. Vincent Street and to the portion of Pitt Street between West George Street and West George Lane;

- (iii) that the restriction on waiting and loading and unloading applicable to the streets described in Part II of Schedule I to the Order should apply to—
 - (a) the portion of Elmbank Street (west side) from a point 40 feet north of the north kerb line of St. Vincent Street northwards for 70 feet;
 - (b) the portion of Pitt Street extending from the south kerb line of West George Street southwards for 15 feet;
 - (c) the portion of Renfrew Street (north side) extending from a point 15 feet east of the east kerb line of Cambridge Street eastwards for 20 feet;
 - (d) the portion of Renfrew Street (south side) extending from a point 15 feet west of the west kerb line of Hope Street westwards for 30 feet;
 - (e) the portion of West George Street (south side) extending from the west kerb line of Pitt Street westwards for 15 feet; and
 - (f) the portion of West George Street (south side) extending from the east kerb line of Pitt Street eastwards for 15 feet;
- (iv) that the restrictions on waiting and loading and unloading applicable to the streets described in Part II of Schedule I to the Order shall cease to apply to certain portions of the following streets, namely:

Bothwell Street
Cambridge Street
Elmbank Street
Newton Street
North Street
St. Vincent Street
Sauchiehall Street and
Wellington Street.

- (v) that the restrictions on waiting and loading and unloading applicable to the streets described in Part III of Schedule 1 to the Order shall apply to:
 - (a) Elmbank Street (west side) from 20 feet north of the north kerb line of Bath Street northwards for a distance of 40 feet.
 - (b) Elmbank Street (east side)—
 - (1) from 20 feet north of the north kerb line of Bath Street northwards for a distance of 40 feet;
 - (2) from 60 feet north of the north kerb line of St. Vincent Street northwards for a distance of 60 feet.
 - (c) Newton Street (west side) from 35 feet south of the south kerb line of Sauchiehall Street southwards for a distance of 100 feet.
 - (d) Newton Street (east side) from 40 feet south of the south kerb line of Sauchiehall Street southwards for a distance of 80 feet.
 - (e) North Street (east side) from 70 feet north of the north kerb line of Bath Street northwards for a distance of 70 feet; and
 - (f) St. Vincent Street (south side) from 50 feet east of the east kerb line of North Street eastwards for a distance of 60 feet.
- (vi) for the designation of official parking places, the extension of the limits of existing parking places, an increase in the number of parking bays which may be provided and the variation of the minimum total lengths within the parking places which must not be occupied by parking bays in respect of the following streets and for prescribing the manner in which vehicles shall stand therein, viz.:
