# PRESENT,

The QUEEN'S Most Excellent Majesty in Council

Whereas by section 3 of the Naval and Marine Pay and Pensions Act 1865, 28 & 29 Vict. c. 73, it is enacted that all pay, wages, pensions, bounty money, grants or other allowances in the nature thereof, payable in respect of services in Her Majesty's naval or marine force to a person being or having been an officer, seaman or marine, or to the widow or any relative of a deceased officer, seaman or marine, shall be paid in such manner and subject to such restrictions, conditions and provisions, as are from time to time directed by Order in Council:

And whereas Her Majesty deems it expedient to amend the Order concerning pensions and other grants in cases where the disablement or death of members of the naval forces is due to service during the 1914 World War and after 2nd September 1939:

Now, therefore, Her Majesty, in exercise of the powers conferred upon Her as aforesaid and of all other powers whatsoever Her thereunto enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

The Order in Council dated 25th September 1964, as amended Orders of 22nd December 1964 and 24th February 1966, relating to members of the naval forces as therein defined (hereinafter referred to as "the 1964 Order") shall be amended in the respects set out in the following provisions of this Order.

Extension of period of temporary allowances to certain widows and unmarried dependants who lived as wives of severely disabled pensioners.

1. In Article 33 of the 1964 Order (temporary allowances to widows and unmarried dependants who lived as wives of severely disabled pensioners) there shall be made the amendment set out in the Appendix hereto.

### Commencement

2. This Order shall come into operation on 6th July 1966.

### APPENDIX

### Amendment of Article 33 of the 1964 Order

In paragraph (a) of Article 33 (2) (temporary allowances to widows of severely disabled pensioners) after the words and figures "for the period of 13 weeks" there shall be inserted the words and figures "or, where the member dies on or after 6th July 1966, 26 weeks."

### EXPLANATORY NOTE

(This Note is not part of the Order)

This Order further amends the Order of 25th September 1964 by extending the period for which temporary allowances are payable to widows, and unmarried dependants who lived as wives, of severely disabled pensioners whose death occurs on or after 6th July 1966.

# TENDERS FOR TREASURY BILLS

- 1. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.

# TRUNK ROADS ACT 1946 CONON BRIDGE DIVERSION

# CONON BRIDGE DIVERSION IMPROVEMENTS

THE Secretary of State gives notice that he has made the London-Edinburgh-Thurso Trunk Road (Conon Bridge Diversion Improvements) Order 1966, under section 14 of the Special Roads Act 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955, which trunk road order provides for:

No person shall, except upon the direction or with the consent of a police constable in uniform, cause or permit any vehicle to wait in the following lengths of road:

- (1) Bank Street.
- (2) Castle Streeet.
- (3) On the south east side of James Street between South Beach/Shell Street and Keith Street.

# The Burgh of Stornoway (Various Streets) (Waiting Restrictions) Order No. 1, 1966

No person shall, except upon the direction or with the consent of a police constable in uniform, cause or permit any vehicle to wait be ween the hours of 8 a.m. and 6 p.m. in any of the following lengths of road:

- (1) On Matheson Road between Stag Road/Westview Terrace and Bayhead.
- (2) On Church Street between Kenneth Street and Crom-well Street.
- (3) On north side of Francis Street between Cromwell Street and Kenneth Street.
- (4) On south side of Francis Street between Kenneth Street and Lewis Street.
- (5) On north side of Point Street between Castle Street and Cromwell Street.
- (6) On west side of Cromwell Street between North Beach and Kenneth Street.
- (7) On east side of Cromwell Street between South Beach and Francis Street.

# The Burgh of Stornoway (Various Streets) (Waiting Restrictions) Order No. 2, 1966

No person shall, except upon the direction or with the consent of a police constable in uniform, cause or permit any vehicle to wait between the hours of 8 a.m. and 6 p.m. in any of the following lengths of road:

- (1) On east side of Cromwell Street between North Beach and Kenneth Street.
- (2) On south side of North Beach between Cromwell Street and Castle Street.
- (3) On south side of Francis Street between Cromwell Street and Kenneth Street.
- (4) On south side of Point Street between Castle Street and Cromwell Street.
- (5) On south side of South Beach between Cromwell Street and James Street—
  - (a) for a longer period than twenty minutes; or
  - (b) if a period of less than twenty minutes has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on that side.

Nothing in any of the forementioned Orders shall prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to for so long as may be necessary: (a) to enable a person to board or alight from the vehicle; (b) to enable goods to be loaded on to or unloaded from the vehicle; or (c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to or the laying, erection, alteration or repair in or near to any of the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraphic line as defined in the Telegraph Act, 1878.
