REFERENCE TO THE NATIONAL BOARD FOR PRICES AND INCOMES

BANK CHARGES

THE published profits of the London Clearing banks and the Scottish banks and the dividends paid to their shareholders have in most cases increased substantially over recent years. Bank profits are based in part on the general level of interest rates (and particularly Bank Rate) and in part on charges made to customers for services. In view of the important role which these banks play in the economic life of the country, it is, in the Government's view, desirable in the public interest that the system and level of charging customers should be reviewed by the National Board for Prices and Incomes in the light both of the bank's profit and dividend record and of the general considerations set out in the White Paper on Prices and Incomes Policy (Cmnd. 2639). It is not intended that the Board should concern itself with questions of monetary policy such as Bank Rate and the general level of interest rates. The Board are accordingly requested to put in hand the necessary inquiries.
