A PROCLAMATION

FOR APPOINTING TUESDAY, DECEMBER 27th, 1966, A BANK HOLIDAY AND A PUBLIC HOLIDAY IN ENGLAND AND WALES AND IN NORTHERN IRELAND

ELIZABETH R.

Whereas We consider it desirable that Tuesday, the twenty-seventh day of December one thousand nine hundred and sixty-six, should be observed as a holiday in England and Wales and in Northern Ireland:

We do hereby appoint the said twenty-seventh day of December to be observed as a Public Holiday in England and Wales and in Northern Ireland and by this Our Royal Proclamation command the said day to be so observed and all Our loving subjects to order themselves accordingly:

And We do further hereby, by and with the advice of Our Privy Council, in exercise of the powers conferred by section 4 of the Bank Holidays Act 1871, and section 3(3) of the Customs and Excise Act 1952, appoint the said twenty-seventh day of December to be observed in England and Wales and in Northern Ireland as a Bank Holiday, and as a holiday in the customs and excise, under and in accordance with the said Acts.

Given at Our Court at Buckingham Palace, this eleventh day of August, in the year of our Lord one thousand nine hundred and sixty-six, and in the fifteenth year of Our Reign.

A PROCLAMATION

REVOKING THE FOREIGN COINS (IMPORTATION PROHIBITION) PROCLAMATION 1919

ELIZABETH R.

Whereas by a Proclamation, dated the fourteenth day of January, one thousand nine hundred and nineteen, made in pursuance of section two of the Customs Amendment Act 1886, the importation was prohibited into the United Kingdom of all coins coined in any foreign country other than gold or silver coins:

And Whereas it appears to Us that the said Proclamation should be revoked:

Now, therefore, We, by and with the advice of Our Privy Council, in pursuance of the said Act and of all other powers enabling Us in that behalf, do hereby proclaim that the said Proclamation of the fourteenth day of January, one thousand nine hundred and nineteen is revoked.

Given at Our Court at Buckingham Palace, this eleventh day of August, in the year of our Lord one thousand nine hundred and sixty-six, and in the fifteenth year of Our Reign.

REFERENCE TO THE NATIONAL BOARD FOR PRICES AND INCOMES

GENERAL REPORT

THE National Board for Prices and Incomes was set up by Royal Warrant on 8th April 1965. Since that time it has examined a number of questions relating to prices charged for goods or services and to claims, settlements or questions relating to pay or other conditions of service or employment and has made Reports on these.

The Government considers that it would be useful to complement these individual Reports by a general Report covering the period since the Board was set up and the Board are accordingly requested to make such a Report. 9th August 1966.

THE Minister of Labour hereby gives notice that on 3rd August 1966 he made the Offices, Shops and Railway Premises Act 1966 (Exemption No. 4) Order 1966. S.I. 1966 No. 975.

This Order renews for a period of two years commencing with 3rd August 1966 the exemption granted by The Offices, Shops and Railway Premises Act 1963 (Exemption No. 2) Order 1964. The Order exempts railway signal boxes which were constructed before 1st August 1964 and which are situated 200 yards or more from a piped water supply from the requirement of section 10 of the Offices, Shops and Railway Premises Act 1963 that water supplied for washing shall be running water. The Order also exempts for the same period railway signal boxes constructed before 1st August 1964 where there is a piped water supply within 200 yards but no effective means of heating running water from the requirement that clean running hot and cold or warm water shall be provided for washing. The latter exemption is granted subject to the conditions that clean running cold water and means of heating water for washing are provided.

MINISTRY OF POWER

The Petroleum (Production) Regulations, 1966 (S.I. 1966 No. 898)

THE Minister of Power announces that applications for production licences for landward areas may be made on 8th August 1966 and thereafter until further notice.

Following is a summary of the consideration which the Minister, with the consent of the Treasury, has decided to require until further notice in respect of production licences granted for landward areas.

- (1) Upon grant of the licence the sum of ten shillings for each square kilometre comprised in the licensed area.
- (2) Upon the first and second anniversaries of the grant of the licence the sum of ten shillings for each square kilometre then comprised in the licensed area.
- (3) Upon the third, fourth and fifth anniversaries the sum of one pound for each square kilometre then comprised in the licensed area.
- (4) Upon the sixth anniversary the sum of twenty pounds for each square kilometre then comprised in the licensed area and upon each subsequent anniversary a sum increasing annually by ten pounds per square kilometre until on the fifteenth and subsequent anniversaries an annual sum of one hundred and ten pounds will be payable for each square kilometre comprised in the licensed area.
- (5) A royalty on crude oil won and saved in each licensed area during each year;
 - (a) of 5% of the wellhead value of the first 100,000 metric tons;
 - (b) of $7\frac{1}{2}$ ° of the wellhead value of the next 50,000 metric tons;
 - (c) of 10% of the wellhead value of the next following 50,000 metric tons;
 - (d) of 12½% thereafter.

The periodic payments mentioned in (1) to (4) above in respect of a licensed area may be deducted from any royalties due in respect of any crude oil or natural gas won and saved in that area during the year in question.

(6) An identical scale of royalties for natural gas won and saved, calculated on the basis that 1,400 cubic metres of such gas, measured in the manner set out in the model clauses applicable to such licences, is the equivalent of 1 metric ton of crude oil.

TRUNK ROADS ACT 1946 SPECIAL ROADS ACT 1949 ALEXANDRIA BYPASS

THE Secretary of State gives notice that le has made an order under section 1 of the Trunk Roads Act 1946, as extended by section 14 of the Special Roads Act 1949, and as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955, the effect of which will be that

- (a) a new road which he proposes to construct to bypass Alexandria in the County of Dunbarton will become a trunk road on the date when the order comes into operation.
- (b) those lengths of the existing London-Carlisle-Glasgow-Inverness Trunk Road (A.82) to be superseded thereby in Bonhill, Alexandria and Balloch, will cease to be trunk roads on the 16th May next after the date on which notice is given by the Secretary of State to Dunbarton County Council (who will thereafter become the highway authority responsible for those lengths) that the said bypass is opened for through traffic, and
- (c) the provision of a bridge will be authorised to carry the said trunk road over the navigable waters of the River Leven between Alexandria and the Burgh of Dumbarton.
