## Schedule

1. Save as provided in paragraphs 3 and 4 of this Schedule, no person shall cause or permit any vehicle to wait between 9 a.m. and 6 p.m. on Mondays to Saturdays in Longrow South.
2. Save as provided in paragraphs 3 and 4 of this Schedule, no person shall cause or permit any vehicle to wait between 9 a.m. and 6 p.m. on Mondays to Saturdays in any of the lengths of road specified in appendix 1 to this Schedule longer than 30 minutes in any one hour.
3. The restrictions specified in paragraphs 1 and 2 of this Schedule are not to apply to a vehicle waiting:
(a) to enable a person to board or alight or to load or unload his personal luggage therefrom ;
(b) to enable goods to be loaded on to or unloaded from the vehicle;
(c) in connection with building operations, the removal of any obstructions to traffic or the maintenance, etc., of any public utility services;
(d) if it is a public service vehicle stopping at an authorised stopping place;
(e) if it is a disabled driver's vehicle;
(f) if it is in actual use in connection with a funeral undertaking.
4. Save as provided in paragraph 5 of this Schedule, except upon the direction or with the permission of a Police Constable in uniform no person shall drive or cause or permit to be driven any vehicle in any of the lengths of road specified in the 2 nd Schedule hereto otherwise than in the direction specified opposite such lengths of road.
5. The restrictions specified in paragraph 4 shall not apply to any mechanical road cleansing vehicle between the hours of 8 a.m. and 11 p.m.
