THE Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Sections 9 and 13 of, and Schedule 5 to, the Import Duties Act, 1958, and Section 2(5) of the Finance Act, 1965.

viz.: The Import Duty Drawbacks (No. 8) Order, 1966.

This Order-

- (1) provides for the allowance of drawback of import duty on the exportation-
  - (a) of furniture manufactured from certain imported wood; and
  - (b) of sebacic acid manufactured from imported castor oil;
- (2) in the case of the following exported goods, namely-
  - (a) castor oil manufactured from imported castor seed;

  - (b) chewing gum and chewing confectionery manufactured from imported chewing gum base;
     (c) handbags and certain other leather goods manufactured from certain imported leather;
  - (d) hazelnut products manufactured from imported hazelnuts; and
  - (e) sperm oil refined from imported unrefined sperm

provides, by revoking existing fixed rates of drawback for drawback of import duty related to the duty paid on the imported goods actually used in the manufacture of the exported goods and, in the case of the goods specified in sub-paragraphs (c) and (e) above, removes the condition for drawback that duty shall have been paid at not less than a specified rate;

- (3) varies the rate of drawback of import duty in respect of the following exported goods:
  - (a) animal black of certain descriptions mnaufactured from certain imported bones;
  - (b) apricot kernel products manufactured from certain imported apricot kernels;
  - (c) cigarette papers in the form of booklets manufactured from certain imported cigarette paper; and
  - (d) certain soya bean oil manufactured from imported sova beans;
- (4) corrects the description of certain imported woods used in the manufacture of exported veneer sheets to conform with the Customs Tariff.

The Order comes into operation on 6th October 1966 and has been published as Statutory Instruments 1966, No. 1220.

THE Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Sections 1, 2 and 13 of the Import Duties Act, 1958 viz.: The Import Duties (General) (No. 8) Order, 1966.

This Order makes two amendments in the Customs Tariff consequential upon clarifications approved by the Customs Co-operation Council in the English text of the Brussels Nomenclature. It amends-

- (a) paragraph (c) of the note to Chapter 2 to make it clear that animal fat classified in Chapter 2 includes only animal fat of the type covered by heading 02.05;
- ) note 6(b) to section XI to make clear the meaning of the expression "made up" in relation to certain textile

It also amends heading 90.25 of the Customs Tariff to preserve the previous rate of import duty on environmental test chambers following their re-classification under this heading.

The Order comes into operation on the 6th October 1966, and has been published as Statutory Instruments 1966 No 1219.

## DANGEROUS DRUGS ACT 1965 SUSPENSION OF WITHDRAWAL OF AUTHORITIES

(PETER LOUIS MILBOURNE HARTLEY)

WHEREAS the authorities conferred by the Dangerous Drugs Regulations 1953 on PETER LOUIS MILBOURNE HARTLEY, M.B., Ch.B., M.R.C.S., L.R.C.P., by virtue of his being a duly qualified medical practitioner, to be in possession of and to supply the drugs and preparations to which those Regulations applied were withdrawn in pursuance of the powers conferred on the Secretary of State by Regulation 29 of the said Regulations by notices published in the London Gazette and the Edinburgh Gazette on 13th May 1960, the said Peter Louis Milbourne Hartley, whose registered address was then 408 Wimbledon Park Road, London S.W.19, having been convicted of offences against the Dangerous Drugs Act 1951:

And Whereas at the same time the Secretary of State directed that it should not be lawful for the said Peter Louis Milbourne Hartley to give prescriptions for the purposes of the Dangerous Drugs Regulations 1953:

And Whereas the Dangerous Drugs Regulations 1953 have been revoked and by virtue of Regulation 33 of the Dangerous Drugs (No. 2) Regulations 1964, the said withdrawal and direction are deemed to have been done and given under the said Regulations of 1964:

And Whereas by virtue of Regulation 22 of the Dangerous Drugs (No. 2) Regulations 1964 the Secretary of State is empowered at any time to restore such an authority as aforesaid which has been withdrawn under the said Regulations, or to suspend such a withdrawal:

And Whereas I am satisfied that it is expedient to suspend the said withdrawal of authorities from the said Peter Louis Milbourne Hartley:

Now, Therefore, I hereby suspend, in pursuance of the powers conferred upon me by Regulation 22 of the Dangerous Drugs (No. 2) Regulations 1964, the said withdrawal of authorities from the said Peter Louis Milbourne Hartley, and I further suspend the operation of the said direction regarding prescriptions given by the said Peter Louis Milbourne Hartley.

## SPECIAL ROADS ACT 1949

## NEW ROAD BETWEEN BLAIRADAM AND ARLARY, KINROSS-SHIRE

THE Secretary of State gives notice that he proposes to make a scheme under sections 1, 2 and 9 of the Special Roads Act 1949, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955, the effect of which will be:

- (a) to provide for a special road commencing from a point south of the junction between the access road to Kinnaird and the Inverkeithing-Perth Trunk Road (A.90) near Blairadam in the County of Kinross and proceeding in a general north-westerly and then north-easterly direction to a point south west of the junction between the said trunk road and the access to Blairfield near Arlary in the County of Kinross, for the exclusive use of traffic of Classes I and II set out in Schedule 2 to the said Act as varied by the Special Roads (Classes of Traffic) (Scotland) Order 1964; and
- (b) to provide that that part of the special road which is to be provided by the construction of a new road shall become a trunk road on the date of the coming into operation of this scheme.

## BURGH OF PAISLEY CLEAN AIR ACT, 1956

The Paisley No. 7 (Millarston/Castlehead/Brodie Park)
Smoke Control Area Order, 1966

- 1. NOTICE is hereby given that the Provost, Magistrates and Councillors of the Burgh of Paisley, in exercise of the powers conferred on them by Section 11 of the above-mentioned Act on the 13th day of September 1966, made an Order entitled "The Paisley No. 7 (Millarston/Castlehead/Brodie Park) Smoke Control Area Order, 1966," declaring the area described in the schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for Scotland for confirmation.
- 2. Subject to the exemptions provided by the Order and by virtue of Section 11(4) of the Act, if, on any day after the Order has come into operation smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels
