PRICES AND INCOMES ACT, 1966

REFERENCE TO THE NATIONAL BOARD FOR PRICES AND INCOMES

Distribution Costs of Fresh Fruit and Vegetables

THE Minister of Agriculture, Fisheries and Food has had discussions with the National Federation of Fruit and Potato Trades Limited about their recommendation to their members to introduce a surcharge on sales of not less than either 2d. in the £ or 2d. per package to cover rising costs and increased taxation. These discussions took place in the light of the White Paper on the Prices and Incomes Standstill (Cmd. 3073) and of representations by the Retail Fruit Trade Federation Limited.

Arising out of these discussions, the National Federation requested that there should be an inquiry by the National Board for Prices and Incomes into the distribution of fresh fruit and vegetables, and the Retail Fruit Trade Federation supported this. The First Secretary of State and the Minister of Agriculture, Fisheries and Food consider that this would be desirable, and the Minister of Agriculture, Fisheries and Food has asked that the surcharge by wholesalers on fruit and vegetable sales in respect of costs that could not be absorbed should not exceed 1d. in the £ pending a report by the Board.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act, 1966, the First Secretary of State and the Minister of Agriculture, Fisheries and Food hereby refer to the National Board for Prices and Incomes for examination the question of the costs and profit margins of the wholesale and retail fruit and vegetable trades.
