

#### United States of America

THE Secretary of State gives Notice in pursuance of the above-named Regulations that he hereby recognises the Official Crtificate of which particulars are given in the Schedule hereto as showing (a) that the meat to which it relates or the meat from which the meat product to which it relates was prepared, was derived from animals inspected

The Certificate is in the form of a stamp or impression and recognition will apply only if it is clearly shown on the meat or the package containing the meat or meat product.


