This Order

- (i) revokes the existing fixed rate of drawback of import duty for exported neckties, bow-ties and cravats manufactured from certain imported woven fabric and provides for drawback to be related to the duty paid

on the imported goods actually used in the manufacture of the exported goods, and

- ii) reduces the rates of drawback of import duty for specified exported orange marmalade and for certain oranges manufactured from imported fresh bitter oranges.

3. SERVICES AND FACILITIES (when provided)

A. B. The distance for a call is measured between the group centre (as determined in accordance with regulation 18(1) of the Telephone Regulations 1965) of the group into which the exchange serving the telephone from which the call is made has been classified under that regulation and the group centre (as determined by the telephone administration of the Republic of Ireland) of the group into which the exchange in the Republic of Ireland serving the telephone to which the call is made has been classified by that telephone administration.

*Calls from Coin Box Lines—Rebate allowed to Coin Box Line Subscribers*

HER Majesty's Postmaster General hereby gives notice in accordance with regulation 21(4) of the Telephone Regulations 1965, as amended by the Telephone Amendment (No. 2) Regulations 1966, that on and after 1st January 1967 the rates at which rebates are to be allowed to coin box line subscribers under regulation 21(2) of the said Regulations as amended are as follows:

## 1. LOCAL CALLS

- (1) *From an installation or telephone served by an exchange at which the Subscriber Trunk Dialling facility is available*

On each 6d. recorded by the Postmaster General as having been collected in the coin collecting box, the rebate shall be 2d.

(2) *Otherwise*

On each 4d. recorded by the Postmaster General as having been collected, the rebate shall be:

- (a) 1½d. where the exchange line is provided at the residence rate of rental;  
(b) 1d. where the exchange line is provided at the business rate of rental.

## 2. OTHER CALLS

- (1) *Where the call is obtained without the intervention of the Post Office operator*

On each 6d. recorded by the Postmaster General as having been collected, the rebate shall be 2d.

(2) *Otherwise*

On the sum recorded by the Postmaster General as having been collected:

- (a) For an inland trunk call or a call from Northern Ireland to the Republic of Ireland, where the call is made in the cheap rate period and its chargeable duration is three minutes or an odd multiple of three minutes, the rebate shall be 3d. for each call.  
(b) For a call made to a radiotelephone (see regulation 37(1)) from a coin box line served by an exchange in the same radio charging group, the rebate shall be 3d. for each separate three minutes or part of three minutes of the chargeable duration of the call.  
(c) For other calls the rebate shall be 6d. for each call.

*Notes*

B. Except where otherwise stated, the rebates specified apply whether the call is made in the full rate period or the cheap rate period.

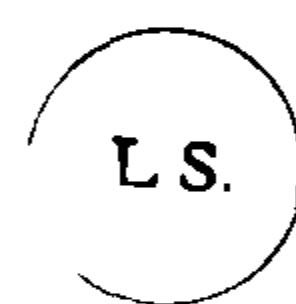

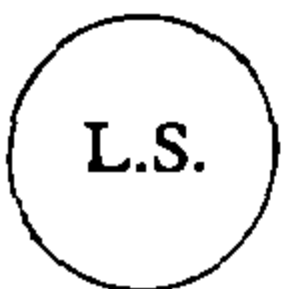

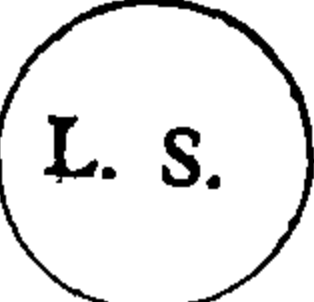
