THE Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Sections 3(6) and 13 of the Import Duties Act, 1958, viz.: The Import Duties (Temporary Exemptions) (No. 6) Order, 1966.

This Order provides that the goods listed in Schedule 1 shall be temporarily exempt from import duty, and those listed in Schedule 2 shall continue to be exempt from import duty, both until 31st December 1966.

This Order comes into operation on the 3rd November 1966, and has been published as Statutory Instruments 1966 No. 1334.

THE Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Sections 9 and 13 of, and Schedule 5 to, The Import Duties Act, 1958, and Section 2(5) of the Finance Act, 1965.

Viz.: The Import Duty Drawbacks (No. 9) Order, 1966.

This Order

(i) revokes the existing fixed rate of drawback of import duty for exported neckties, bow-ties and cravats manufactured from certain imported woven fabric and provides for drawback to be related to the duty paid on the imported goods actually used in the manufacture of the exported goods, and

reduces the rates of drawback of import duty for specified exported orange marmalade and for certain oranges manufactured from imported fresh bitter oranges.

This Order comes into operation on 3rd November 1966 and has been published as Statutory Instruments 1966, No. 1335.

MADE-UP TEXTILES WAGES COUNCIL (GREAT BRITAIN)

THE Made-up Textiles Wages Council (Great Britain) hereby gives notice of its intention to submit to the Minister of Labour proposals for 1) varying the provisions relating to statutory minimum remuneration set out in the Wages Regulation (Made-up Textiles) Order 1965 (Order MT(58)); (2 amending the provisions r lating to holidays and holiday remuneration set out in the Wages Regulation (Made-up Textile Holidays) Order 1963 (Order MT(54)); and (3) the revocation of Order MT 58) and Order MT(54).
