Statutory Instruments 1966 No. 1319

Parrots and Miscellaneous Birds (Prohibition of Importation) (Revocation) Order 1966

(Made 20th October 1966)

This Order revokes the Parrots and Miscellaneous Birds (Prohibition of Importation) Order 1953, as amended, so that henceforward the importation of parrots and similar birds into Great Britain is no longer prohibited.

The Importation of Horses, Asses and Mules

Dated this 1st day of November 1966.

NOTICE is hereby given in pursuance of Section 85(3) of the Diseases of Animals Act 1950 that the Minister of Agriculture, Fisheries and Food and the Secretary of State for Scotland, acting jointly, have made the following Orders which came into operation on 1st November 1966: (Amendment) (No. 2) Order 1966

(Made 21st October 1966)

This Order revokes the Importation of Horses, Asses and Mules (Amendment) Order 1966, which imposed temporary licensing restrictions on the importation of horses in order to prevent the introduction of infectious equine anaemia.

An imported horse must be accompanied by a foreign veterinary certificate that the premises on which it has been kept have been free from certain diseases. This Order reduces the period to be covered by the certificate from twelve months to six.

Statutory Instruments 1966 No. 1349

The Importation of Horses, Asses and Mules (African Horse Sicknes) (Amendment) Order 1966

(Made 27th October 1966)

This Order prohibits the importation of hor es (including a ses, mules and hinnies) and zebras from Gibraltar, Portugal and Spain, in order to prevent the introduction of African horse sickness into Great Britain.

Public Health (Imported Food) (Scotland) Regulations 1937 to 1948

UNITED STATES OF AMERICA

THE Secretary of State gives notice in pursuance of the above-named Regulations that he hereby recognises the Official Certificate of which particulars are given in the Schedule hereto as showing (a) that the meat to which it relates or the meat from which the meat products to which it relates was prepared, was derived from animals inspected ante and post-mortem and passed in accordance with criteria satisfactory to the Secretary of State, and (b) that all necessary precautions for the prevention of danger to the Public Health were taken in the dressing or preparing of the meat or meat products.


The Certificate, being in the form of a label, the recognition will apply only if the label is securely affixed to the meat or the package containing the meat or meat products, and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate.

The label hereby recognised is in addition to the Official Certificate as published in the Edinburgh Gazette of 5th June 1964 and 21st October 1966 for the importation of meat and meat products from the United States of America, and will continue to be recognised until 31st March 1967 when it will be revoked.


