TENDERS FOR TREASURY BILLS

SCHEDULE

The order revokes the existing by-laws made by the Magistrates of Jedburgh Town Council imposing unilateral waiting restrictions between 10.30 a.m. to 5 p.m. Monday to Saturday inclusive, on High Street, Jedburgh, between the Junction with Queen Street and its junction with Canongate and Exchange Street at Market Place and reimposes unilateral waiting on the same length but with the restrictions in force from 9.30 a.m. to 6 p.m. and with waiting limited to 30 minutes in any hour on that side of the road on which vehicles are not prohibited from waiting for the time being. Exemptions are provided in the Order to enable vehicles to wait for so long as may be necessary for persons to board or alight, or to be used in connection with building or demolition operations, etc.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.
