No person shall cause or permit any vehicle to wait at any time in the lengths of roads specified hereunder:

1. That length of South Road *ex adverso* the north footpath of South Road.
2. That length of West Road *ex adverso* the east footpath of West Road.
3. That length of North Road *ex adverso* the south footpath of North Road.
4. That length of East Road *ex adverso* the west footpath of East Road.
5. Those lengths of South, West, North and East Roads *ex adverso* the south, west, north and east footpaths of said roads respectively within a distance of ten yards from any corner or junction of said roads with any other roads or vehicular entrances.

CLEAN AIR ACT, 1956

THE BURGH OF FALKIRK

Smoke Control Area Order (No. 5), 1966

1. NOTICE is hereby given that the Provost, Magistrates and Councillors of the Burgh of Falkirk in exercise of the powers conferred on them by section 11 of the above mentioned Act on the Twenty-seventh day of December Nineteen Hundred and Sixty-six made an order entitled The Burgh of Falkirk Smoke Control Area Order (No. 5), 1966, declaring the area described in the schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for Scotland for confirmation.

2. Subject to the exemptions provided by the Order and shown in the schedule hereto and by virtue of section 11(4) of the Act if, on any day after the Order has come into operation smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals, fluidised char binderless briquettes manufactured by the National Coal Board and "Multiheat" briquettes having anthracite as a main constituent which have been subjected to a mild heat treatment process, and manufactured by the National Coal Board.

3. The Order will come into operation on the First day of November Nineteen Hundred and Sixty-seven or on such later date as is not earlier than six months from the date of the confirmation of the Order by the Secretary of State for Scotland.

4. Copies of the Order and of the Map referred to therein may be inspected free of charge at the Town Clerk's Office, Municipal Buildings, Falkirk at all reasonable times during the period of six weeks from the Twenty-eighth day of January Nineteen Hundred and Sixty-seven.

5. Within the said period any person who may be affected by the Order may by notice in writing to the Secretary, Scottish Development Department, St. Andrew's House, Edinburgh 1, object to the confirmation of the Order.

6. In order to qualify for grant for adaptation of a fire-place, expenditure must be incurred to the satisfaction of the said Burgh either (i) by the owner or occupier or other interested person after confirmation of the Order with the approval of the said Burgh, and incurred before the Order comes into operation or (ii) by the owner or occupier required by a notice under Section 12(2) of the said Act served at any time after the confirmation of the Order.

SCHEDULE

1. The area lying within the Burgh of Falkirk and County of Stirling and situated in the South part of the burgh comprising 163 acres or thereby bounded as follows: On the north by the Camelon Road from Maggie Woods Loan eastwards, West Bridge Street, Cockburn Street and Hodge Street; On the east by the Cow Wynd and High Station Road; On the South by the Edinburgh-Glasgow railway to the eastern boundary of Windsor Hospital; and on the west by the West Ward boundary from the railway to Camelon Road.
