

**BURGH OF KEITH (MID STREET) TRAFFIC  
REGULATION ORDER, 1967**

**SCHEDULE**

The effect of the Order is (1) to prohibit the waiting of vehicles in that part of Mid Street, Keith, between Church Road (A.96) and Reidhaven Square, between the hours of 8 a.m. to 12 midnight, (a) on the east side of the said part of Mid Street on those days of the month which bear odd numbers and (b) on the west side of said part of Mid Street on those days of the month which bear even numbers and (2) to limit, between the hours of 8 a.m. and 6 p.m. the period of waiting, on that side of the said part of said street on which waiting is not for the time being prohibited, to a maximum period of 20 minutes in any period of one hour.

**BURGH OF WHITBURN**

*Extension of Burgh Boundaries*

NOTICE Is Hereby Given that an application has been presented to the Sheriff of the Lothians and Peebles at Linlithgow, at the instance of the Provost, Magistrates and Councillors of the Burgh of Whitburn, craving the Court to revise, alter and extend the boundaries of the said Burgh, so as to Include the area of land delineated and hatched green on the Plan which has been lodged with said application in the Office of the Sheriff Clerk at Linlithgow, and to Exclude the area of land delineated and hatched yellow on said Plan, the New Boundaries of said Burgh to be as follows:

The existing boundary on the west shall continue only so far as the said existing boundary on the west meets the Public Highway known as A.8 from where the North boundary shall follow the line of the south side of the said A.8 in an easterly direction until the point where the said A.8 meets the existing North boundary of the said Burgh at the River Almond from where the boundary line shall follow the existing boundary along the said River Almond in an easterly direction past the point where the said River Almond touches the existing East boundary of said Burgh, following the line of the said River Almond and then shall follow a westerly direction and then a southerly direction to cross the Public Highway known as A.705 and to continue in a southerly direction and then to follow a South-eastern direction as far as the White Burn from where the boundary line shall follow in a westerly direction the line of the said White Burn up to the point where said White Burn joins a stream leading from the area around the Old Quarries from which point the boundary shall follow a south-south easterly and then a South-westerly direction and thereafter a Southerly south-easterly and easterly direction round past the said Old Quarries after which the boundary shall follow a south-easterly direction and then shall follow a curve in the same direction down to a drain draining the lands of the Farm of Blaeberryhill, where the boundary shall follow the line of the said drain in a westerly direction and then southwards until it reaches the Bickerton Burn, where the boundary shall follow the line of the said Bickerton Burn in a South westerly and then north westerly and then westerly direction up to the area around Bickerton Hall where the boundary shall follow a north westerly and then south westerly direction until it reaches the Public Highway known as A.706 where it shall follow the curve of the east side of said A.706 in a northerly direction to the point where the said A.706 joins the access road leading past Reveston House, where the boundary shall follow the line of the North side of said access Road in a South westerly direction past Reeves Farm buildings to take a North westerly direction up to Cultrig Burn from where the boundary shall follow the line of the said Cultrig Burn in a westerly and then southerly direction and then a north westerly direction past the railway sidings adjacent to Polkemmet Colliery after which it shall follow a westerly, North westerly and then northerly direction until it reaches the existing south boundary of said Burgh where it follows the line of the said existing south boundary in a south westerly, North westerly then northerly direction until it reaches the said A.705 along the North side of which it follows an easterly direction for a short distance to take up a northerly direction to the point where said existing boundary reaches the south side of

said A.8 and to appoint the said new Boundaries to take effect as from 16th May 1967, and to grant warrant to record this application and the deliverance thereon in the Books of Court.

To which application his Lordship appended the following Interlocutor:

"*Linlithgow, 22nd December 1966.* The Sheriff of Lothians and Peebles having considered the foregoing Petition, Appoints a copy thereof and of this Deliverance to be served upon the Clerk to the West Lothian County Council: Further Appoints intimation of the import of the Petition and of this Deliverance to be made by advertisement once in each of the *Edinburgh Gazette* and *Scotsman*, *West Lothian Courier* and *Linlithgowshire Journal and Gazette* newspapers: Allows all parties having an interest and desiring to be heard to lodge a Note of their objections with the Sheriff Clerk at Linlithgow within fourteen days from the last date of said advertisements: Appoints the Petition and relative Plan to remain in the office of the said Sheriff Clerk till further orders of Court for inspection by all concerned."
