The Pay and Conditions of Manual Workers in Local

Authorities, the National Health Service, Gas and Water

Supply

Statutory Instruments 1967 No. 267 (S. 16) HIGH COURT OF JUSTICIARY, SCOTLAND Act of Adjournal (Sittings of the High Court of

Justiciary, Glasgow) 1967

Made 14th February 1967

Coming into Operation 1st October 1967

THE Lord Justice-General, Lord Justice-Clerk and Lords Commissioners of Justiciary, under and by virtue of the powers conferred upon them by section 1 of the Circuit Courts and Criminal Procedure (Scotland) Act 1925(a) and of all other powers vested in them in that behalf, and after consultation with the Lord Advocate, do hereby enact and declare as follows:

- 1. That the Sittings of the High Court of Justiciary for the Western Circuit at Glasgow shall be held, commencing with a Sitting in January 1968, in the months of January, February, March, May, June, July, September, October, November and December respectively in each year: provided that the Sittings of the said Court at Glasgow prior to January 1968 shall be held in accordance with existing law and practice.
- 2. That the dates of each of the said Sittings at Glasgow in each year from and after, but not including, 1967 shall be fixed by Act of Adjournal on a date not later than the end of November of the preceding year.
- 3. This Act of Adjournal may be cited as the Act of Adjournal (Sittings of the High Court of Justiciary, Glasgow) 1967, and shall come into operation on 1st October 1967.

And the Lords Appoint this Act of Adjournal to be recorded in the Books of Adjournal, and to be published in the Edinburgh Gazette.
