COSTS AND REVENUE OF NATIONAL DAILY NEWSPAPERS

Under the arrangements for voluntary early warning of price increases, the International Publishing Corporation Limited have notified the Board of Trade that they propose to increase the price of the Daily Mirror from 4d. to 5d. from a date later in 1967.

In view of the special role of the newspaper industry and of the economic problems which the industry is currently facing, the Government consider that there should be an independent examination of the costs and revenue of the main national daily newspapers.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act, 1966, the First Secretary of State and the President of the Board of Trade hereby refer to the National Board for Prices and Incomes for examination the question of the costs and revenue of the national daily newspapers with a circulation over 200,000, with particular reference to the notification made on behalf of the Daily Mirror.




