Viz.: The Import Duty Drawbacks (No. 9) Order, 1967. This Order:

- (i) extends the scope of the existing provisions for the allowance of drawback of import duty on imported materials used in the manufacture of exported chocolate and sugar confectionery, by adding dried egg albumin to the list of imported materials in respect of which drawback may be paid; and
- (ii) provides for the allowance of drawback of import duty on the exportation of:
 - (a) combing oil (a mixture of refined sperm oil, castor oil and fatty acids) manufactured from imported sperm oil and castor oil; and
 - (b) fatty alcohols manufactured from imported sperm oil.

This Order comes into operation on 5th October 1967, and has been published as Statutory Instruments 1967 No. 1435.



SCHEDULE

The order makes permanent the weight restriction of 30 tons which has been imposed experimentally since 1st February 1967, on vehicles using the length of the Fort William-Mallaig Trunk Road (Route A.830) from the bridge over the Borrodale Burn near Arisaig House to its terminus at Mallaig. It provides for exemption in special cases with the prior permission of the Secretary of State.

SCHEDULE

The effect of the order would be to revoke the Glasgow-Inverness Trunk Road (Fort William) (Restriction of Waiting and Loading) Order, 1966, and to re-enact the provisions of that order with the following amendment:

Waiting would be prohibited at any time and loading would be prohibited between the hours of 10 a.m. and 8 p.m. on the south-east side of the trunk road from its junction with Bank Street in a south-westerly direction for a distance of approximately 35 yards. Waiting on this length is at present limited to 30 minutes in any hour, with no loading between the hours of 10 a.m. and 5 p.m.

The exceptions to the existing order enabling a vehicle to wait for so long as may be necessary for a person to board or alight, to load and unload (outwith the prohibited hours) and to be used in connection with maintenance operations and other works, would not be affected.

Mines and Quarries Act 1954

Draft Coal and Other Mines (Shafts, Outlets and Roads)
(Amendment) Regulations 1967

THE Minister of Power, in accordance with the provisions of Section 142 of, and Part I of the Second Schedule to, the Mines and Quarries Act 1954, hereby gives notice that he proposes to make the Coal and Other Mines (Shafts, Outlets and Roads) (Amendment) Regulations 1967.

These Regulations will apply to mines of coal, stratified ironstone, shale and fireclay and will amend the provisions of the Coal and Other Mines (Shafts, Outlets and Roads) Regulations 1960, in the following two respects:

- (1) Regulation 18 will be amended so as to require the whole of a shaft, staple-pit or unwalkable outlet through any part of which men are carried to be examined and not merely that part of it through which men are actually carried;
- (2) Regulation 19(6), which requires cage suspension gear to be annealed or given other appropriate heat treatment, will be amended to enable the Minister to specify the nature of the heat treatment to be given in particular cases or enable such treatment to be dispensed with where this is in the interests of safety.
