Reference to the National Board for Prices and Incomes
**PROPOSED INCREASES BY BRITISH RAILWAYS
BOARD IN CERTAIN COUNTRY-WIDE FARES
AND CHARGES**

AS announced by the Prime Minister on 7th September 1967, the Government have decided that all future proposals for significant price increases by publicly-owned industries should be referred for examination by the National Board for Prices and Incomes.

The British Railways Board have consulted the Minister of Transport about increases which they propose to make in certain country-wide fares and charges in view of the need to contain their revenue deficit, which amounted to £135 million in 1966, and of their financial duty to balance their accounts as soon as possible.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs and the Minister of Transport hereby refer the question of the increases proposed by British Railways in certain country-wide fares and charges to the National Board for Prices and Incomes for examination against the background of the Government's policies for nationalised industries.

**THE BULK SUPPLY TARIFF OF THE CENTRAL
ELECTRICITY GENERATING BOARD**

AS announced by the Prime Minister on 7th September 1967, the Government have decided that all future proposals for significant price increases by publicly-owned industries should be referred for examination by the National Board for Prices and Incomes.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs and the Minister of Power hereby refer the question of the increase envisaged by the Central Electricity Generating Board in the bulk supply tariff from 1st April 1968, to the National Board for Prices and Incomes

for examination against the background of the Government's policies for nationalised industries, including the financial target for the relevant period.

GAS PRICES

AS announced by the Prime Minister on 7th September 1967, the Government have decided that all future proposals for significant price increases by publicly-owned industries should be referred for examination by the National Board for Prices and Incomes.

The Minister of Power has considered proposals for increases in gas tariffs and in coke prices by Area Boards put forward in the light of cost increases that have already occurred and of the need to increase the Board's earnings to the level necessary to meet their financial obligations. In addition the Gas Council, on behalf of the Boards, have made proposals for recovering additional costs imposed by events in the Middle East.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs and the Minister of Power hereby refer the question of the increases in gas tariffs and coke prices sought by the gas industry to the National Board for Prices and Incomes for examination against the background of the Government's policies for nationalised industries, including the financial target for the relevant period.

POST OFFICE CHARGES

THE Post Office has under consideration changes in the charges both for postal services and for telecommunications services ; both increases and decreases would be involved. It is proposed that there should be an important restructuring of the pattern of postal services, on the basis of replacing the present letter and printed paper services by a two-tier

system providing for a first and second class letter service at differential tariffs. Some changes in the present basis of charging for telephone services are also in mind. In considering what will be needed the Post Office has had regard to the foreseen growth in business and in the size of the telephone system, the expected increases in productivity, the requirements of the Post Office capital investment programme and its financial obligations. The new tariffs would take effect in the case of telecommunications in the summer of 1968 and in the case of postal services in the autumn of 1968.

The Government think it appropriate that these proposed changes should be examined by the National Board for Prices and Incomes. Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs and the Postmaster-General hereby refer the question of the proposed changes in Post Office charges to the National Board for Prices and Incomes for examination on the assumption that the financial objectives of the postal and telecommunications services and the general programme of development for the industry are as approved by the Government for the relevant period.

Draft Special Regulations

Offices, Shops and Railway Premises Act, 1963

THE OFFICES, SHOPS AND RAILWAY PREMISES (HOISTS AND LIFTS) REGULATIONS 1967

IN pursuance of section 80 of, and Schedule 1 to, the Offices, Shops and Railway Premises Act 1963, the Minister of Labour hereby gives notice that he proposes to make special regulations imposing requirements as to the construction, maintenance and examination of hoists and lifts in offices, shops and railway premises. The regulations will also provide for liftways to be enclosed and for the provision of gates fitted with devices for securing that the gates cannot be opened unless a lift is at the landing and that a lift cannot be moved away from the landing until the gates are closed. They will also require that every lift shall be marked with its maximum safe working load. The Regulations contain exemptions from certain requirements of certain lifts and hoists subject to specified conditions and limitations.

ETHIOPIA

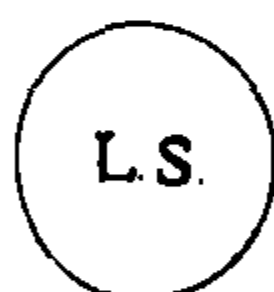

- (b) from a point on the route described in sub-paragraph (a) above 28 yards or thereby north of the centre line of Paisley Road, Glasgow, south-westwards for a distance of 356 yards or thereby to a point 17 yards or thereby east of the centre line of Weir Street, Glasgow, and 43 yards or thereby north of the centre line of Ardgowan Street, Glasgow.

2. A scheme under sections 1, 2 and 9 of the Special Roads Act, 1949, the effect of which will be to authorise the provision of special roads (motorways) at the seven road junctions described below for the exclusive use of traffic of Classes I and II set out in Schedule 2 of the said Act as varied by the Special Roads (Classes of Traffic) (Scotland) Order, 1964 to connect the special roads described in paragraph 1 hereof to existing all-purpose surface roads, viz.:

- (a) Junction of the motorway with West Street/Gloucester Street;
- (b) Junction of the motorway with Ardgowan Street;
- (c) Junction of the motorway with Stobcross Street;
- (d) Junction of the motorway with Great Western Road (as extended);
- (e) Junction of the motorway with Craighall Road (as extended);
- (f) Junction of the motorway with Castle Street;
- (g) Junction of the motorway with Alexandra Parade.

3. An order under sections 3 and 7 of the Special Roads Act, 1949, the effect of which will be to authorise the Corporation:

- (a) to appropriate, as part of the special roads, those roads for which the Corporation are the highway authority and which are comprised in the routes of the special roads;
- (b) to improve, raise, lower or otherwise alter roads;
- (c) to stop up roads and construct new roads;
- (d) to stop up private means of access and to provide new means of access—all in the vicinity of the routes of the special roads described in paragraph 1 hereof.
