

#### A PROCLAMATION

#### DETERMINING A NEW DESIGN FOR SILVER AND CUPRO-NICKEL CROWN PIECES AND MAKING THE SAID CROWN PIECES CURRENT AND LEGAL TENDER IN GIBRALTAR.

#### ELIZABETH R.

Whereas by virtue of Proclamation issued under the Coinage Acts 1870 to 1946 certain parts of those Acts are in force in Gibraltar:

And Whereas it appears to Us desirable to determine a new design, hereinafter specified, for the silver Crown, being one of the silver coins mentioned in the Schedule to the Coinage Act 1870 and for the cupro-nickel Crown, being one of the cupro-nickel coins mentioned in the Schedule to the Coinage Act 1946, to be struck at Our Mint in London, and to order that the said Crowns shall be current and legal tender in Gibraltar:

# BY THE QUEEN A PROCLAMATION

#### CALLING IN ALL GOLD, SILVER, MIXED METAL, CUPRO-NICKEL AND BRONZE COINS OF THE UNITED KINGDOM FROM CERTAIN TERRITORIES IN THE EAST CARIBBEAN.

#### ELIZABETH R.

Whereas by virtue of Proclamations of Their late Majesties Queen Victoria and King George the Sixth issued under the Coinage Acts 1870 to 1946 the United Kingdom coins specified in Schedule 1 to this Proclamation are current legal tender in the territories specified in Schedule 2 thereto:

And Whereas under section eleven of the Coinage Act 1870 We have power, with the advice of Our Privy Council, by Proclamation to call in coins of any denomination:

And Whereas it now appears to Us desirable to call in coins specified in Schedule 1 from the territories specified in Schedule 2:

We, therefore, in pursuance of section eleven of the Coinage Act 1870 and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

1. There shall be coined, from time to time, at Our Mint in London silver Crowns and cupro-nickel Crowns of the following design:

For the obverse impression Our Effigy with the inscription "ELIZABETH II D.G. REGINA" and for the reverse a triple towered castle with a key suspended therefrom by a chain with the inscription "GIBRALTAR ONE CROWN" and the date "1967" split on either side of the key. The coin shall have a graining of the edge.

- 2. The said coins shall be current, and be legal tender, within Gibraltar.
- 3. This Proclamation shall come into force on the date of its promulgation in Gobraltar by the Governor and Commander-in-Chief thereof.

Given at Our Court at Balmoral, this tenth day of October in the year of our Lord One thousand nine hundred and sixty-seven and in the sixteenth year of Our Reign.

GOD SAVE THE QUEEN

Now, therefore, by and with the advice of Our Privy Council and in pursuance of section eleven of the Coinage Act 1870 and of all other powers enabling Us in that behalf, We do hereby call in the coins specified in Schedule 1 to this Proclamation from the territories specified in Schedule 2 thereto by the first day of November One thousand nine hundred and sixty-seven, and We do proclaim, declare and direct that after the said date the said coins shall not be current or legal tender in those territories.

#### Renfrew County Development Plan—Amendment No. 30

NOTICE Is Hereby Given that proposals for alterations to the above Development Plan (hereinafter referred to as "the proposals") were submitted to the Secretary of State on the Third day of October 1967. The proposals relate to lard situate within the landward area of the County along the river Clyde near Bishopton and involve the rezoning for industrial use and a principal traffic route of mainly agricultural land and its designation for compulsory acquisition.

- (i) The said The Corporation of the City of Glasgow shall be entitled on the expiration of the period (not being less than 28 days) specified in a declaration executed by them to enter on and take possession of the land in the area designated by the declaration without previous consent or compliance with Sections 83-88 of the Lands Clauses Consolidation (Scotland) Act, 1845. The earliest date at which such a declaration may be executed is the expiration of a period of fourteen days from the date of the recording of the Order in the Register of Sasines.
- (ii) On the recording of a Notice of Title in the appropriate Register of Sasines the said land shall vest in the said The Corporation of the City of Glasgow.

A certified copy of the proposals has also been deposited for inspection by the public at the office of the District Clerk, Third District Council, District Council Offices, Bishopton.
