### TENDERS FOR TREASURY BILLS

- 1. Brook Street, Broughty Ferry—
  - a. On the north side thereof:
    - (i) For a distance of 45 feet or thereby eastwards from the intersection of the north kerbline of Brook Street with the east kerbline of Fort Street; and
    - (ii) For a distance of 45 feet or thereby westwards from the intersection of the north kerbline of Brook Street with the west kerbline of Gray Street; and
    - (iii) For a distance of 45 feet or thereby eastwards from the intersection of the north kerbline of Brook Street with the east kerbline of Gray Street; and
    - (iv) For a distance of 45 feet or thereby westwards from the intersection of the north kerbline of Brook Street with the west kerbline of St. Vincent Street.

- b. On the south side thereof:
  - (i) For a distance of 45 feet or thereby eastwards from the intersection of the south kerblines of Brook Street with the east kerblines of Fort Street; and
  - (ii) For a distance of 45 feet or thereby westwards from the intersection of the south kerblines of Brook Street with the west kerblines of Gray Street; and
  - (iii) For a distance of 45 feet or thereby eastwards from the intersection of the south kerblines of Brook Street with the east kerblines of Gray Street; and
  - (iv) For a distance of 45 feet or thereby westwards from the intersection of the south kerblines of Brook Street with the west kerblines of St. Vincent Street.
2. Fort Street, Broughty Ferry—
  - a. For a distance of 45 feet or thereby northwards from the intersection of the east kerblines of Fort Street with the north kerblines of Brook Street; and
  - b. For a distance of 45 feet or thereby southwards from the intersection of the east kerblines of Fort Street with the south kerblines of Brook Street.
3. Gray Street, Broughty Ferry—
  - a. On the west side thereof:
    - (i) For a distance of 45 feet or thereby southwards from the intersection of the west kerblines of Gray Street with the south kerblines of Queen Street; and
    - (ii) For a distance of 45 feet or thereby northwards from the intersection of the west kerblines of Gray Street with the north kerblines of Brook Street; and
    - (iii) For a distance of 45 feet or thereby southwards from the intersection of the west kerblines of Gray Street with the south kerblines of Brook Street; and
    - (iv) For a distance of 45 feet or thereby northwards from the intersection of the west kerblines of Gray Street with the north kerblines of Long Lane; and
    - (v) For a distance of 45 feet or thereby southwards from the intersection of the west kerblines of Gray Street with the south kerblines of Long Lane; and
    - (vi) For a distance of 45 feet or thereby northwards from the intersection of the west kerblines of Gray Street with the north kerblines of King Street.
  - b. On the east side thereof:
    - (i) For a distance of 45 feet or thereby southwards from the intersection of the east kerblines of Gray Street with the south kerblines of Queen Street; and
    - (ii) For a distance of 45 feet or thereby northwards from the intersection of the east kerblines of Gray Street with the north kerblines of Brook Street; and
    - (iii) For a distance of 45 feet or thereby southwards from the intersection of the east kerblines of Gray Street with the south kerblines of Brook Street; and
    - (iv) For a distance of 45 feet or thereby northwards from the intersection of the east kerblines of Gray Street with the north kerblines of Long Lane; and
    - (v) For a distance of 45 feet or thereby southwards from the intersection of the east kerblines of Gray Street with the south kerblines of Long Lane; and
    - (vi) For a distance of 45 feet or thereby northwards from the intersection of the east kerblines of Gray Street with the north kerblines of King Street.
4. King Street, Broughty Ferry—
  - a. For a distance of 45 feet or thereby westwards from the intersection of the north kerblines of King Street with the west kerblines of Gray Street; and
  - b. For a distance of 45 feet or thereby eastwards from the intersection of the north kerblines of King Street with the east kerblines of Gray Street.
5. Long Lane, Broughty Ferry—
  - a. On the north side thereof:
    - (i) For a distance of 45 feet or thereby westwards from the intersection of the north kerblines of Long Lane with the west kerblines of Gray Street; and
    - (ii) For a distance of 45 feet or thereby eastwards from the intersection of the north kerblines of Long Lane with the east kerblines of Gray Street.
  - b. On the south side thereof:
    - (i) For a distance of 45 feet or thereby westwards from the intersection of the south kerblines of Long Lane with the west kerblines of Gray Street; and
    - (ii) For a distance of 45 feet or thereby eastwards from the intersection of the south kerblines of Long Lane with the east kerblines of Gray Street.
6. Queen Street, Broughty Ferry—
  - a. For a distance of 45 feet or thereby westwards from the intersection of the south kerblines of Queen Street with the west kerblines of Gray Street; and
  - b. For a distance of 45 feet or thereby eastwards from the intersection of the south kerblines of Queen Street with the east kerblines of Gray Street.
7. St. Vincent Street, Broughty Ferry—
  - a. For a distance of 45 feet or thereby northwards from the intersection of the west kerblines of St. Vincent Street with the north kerblines of Brook Street; and
  - b. For a distance of 45 feet or thereby southwards from the intersection of the west kerblines of St. Vincent Street with the south kerblines of Brook Street.
2. To prohibit (subject to certain exceptions) the waiting of vehicles between 8 a.m. and 6 p.m. on weekdays in any of the following lengths of road:
  1. Brook Street, Broughty Ferry—
    - a. On the north side thereof:
      - (i) From a point 45 feet or thereby eastwards from the intersection of the north kerblines of Brook Street with the east kerblines of Fort Street to a point 158 feet or thereby eastwards from the said intersection; and
      - (ii) From a point 45 feet or thereby eastwards from the intersection of the north kerblines of Brook Street with the east kerblines of Gray Street to a point 317 feet or thereby eastwards from the said intersection.
    - b. On the south side thereof:
      - (i) From the intersection of the south kerblines of Brook Street with the east kerblines of Union Street to a point 45 feet or thereby westwards from the intersection of the south kerblines of Brook Street with the west kerblines of Gray Street; and
      - (ii) From a point 317 feet or thereby eastwards from the intersection of the south kerblines of Brook Street with the east kerblines of Gray Street to a point 45 feet or thereby westwards from the intersection of the south kerblines of Brook Street with the west kerblines of St. Vincent Street.
  2. Gray Street, Broughty Ferry—
    - a. On the west side thereof from a point 45 feet or thereby southwards from the intersection of the west kerblines of Gray Street with the south kerblines of Brook Street to a point 45 feet or thereby northwards from the intersection of the west kerblines of Gray Street with the north kerblines of Long Lane; and
    - b. On the east side thereof from a point 45 feet or thereby southwards from the intersection of the east kerblines of Gray Street with the south kerblines of Long Lane to a point 45 feet or thereby northwards from the intersection of the east kerblines of Gray Street with the north kerblines of King Street.
  3. Union Street, Broughty Ferry—
 On both sides thereof for the whole length of the road.

3. To prohibit (subject to certain exceptions) the waiting of vehicles between 8 a.m. and 6 p.m. on weekdays (a) for a period longer than thirty minutes, or (b) if a period of less than thirty minutes has elapsed since the termination of the last period of waiting of the vehicle in any of the following lengths of road:

1. Brook Street, Broughty Ferry—

(a) On the north side thereof:

- (i) From a point 158 feet or thereby eastwards from the intersection of the north kerbline of Brook Street with the east kerbline of Fort Street to a point 45 feet or thereby westwards from the intersection of the north kerbline of Brook Street with the west kerbline of Gray Street; and
- (ii) From a point 317 feet or thereby eastwards from the intersection of the north kerbline of Brook Street with the east kerbline of Gray Street to a point 45 feet or thereby westwards from the intersection of the north kerbline of Brook Street with the west kerbline of St. Vincent Street.

(b) On the south side thereof:

- (i) From a point 45 feet or thereby eastwards from the intersection of the south kerbline of Brook Street with the east kerbline of Fort Street to the intersection of the south kerbline of Brook Street with the west kerbline of Union Street; and
