SCHEDULE

- 1. The effect of the proposed Order is to prohibit or restrict, to the respective extents indicated in the Appendix hereto, and except upon the direction or with the permission of a Police Constable in uniform, the waiting of vehicles in a part or parts of the streets referred to in the said Appendix, or, in the case of the streets indicated in capital letters in that Appendix, in the whole of those streets. The prohibition or restriction does not apply in the case of vehicles waiting for certain purposes mentioned in the Order, including, in particular, and subject to the provisions of the Aberdeen City Acts, 1936 to 1955, the waiting of vehicles for so long as may be necessary to enable goods to be loaded or unloaded.
- 2. The proposed Order also prohibits traffic from proceeding otherwise than (a) southwards in Carmelite Street between the Green and Rennie's Wynd; (b) eastwards and southwards in Crown Terrace; (c) westwards in Hadden Street between Carmelite Lane and the Green; (d) southwards in Harriet Street; (e) eastwards in St. John's Place; and (f) westwards in St. Mary's Place.
- 3. A copy of the proposed Order is available for public inspection in the Town Clerk's Office, Town House, Aberdeen, during normal business hours and a map indicating the proposals in detail is similarly available at the City Engineer's Department, Traffic Engineering Section, Bon-Accord Baths, Aberdeen.

CLEAN AIR ACT, 1956 THE BURGH OF FALKIRK

Smoke Control Area Order (No. 7), 1967

- 1. NOTICE Is Hereby Given That The Provost, Magistrates and Councillors of the Burgh of Falkirk in exercise of the powers conferred on them by Section 11 of the above mentioned Act on the Twenty-sixth day of June Nineteen Hundred and Sixty-seven made an Order entitled The Burgh of Falkirk Smoke Control Area Order (No. 7), 1967, declaring the area described in the Schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for Scotland for confirmation.
- 2. Subject to the exemptions provided by the Order and shown in the schedule hereto and by virtue of Section 11(4) of the Act if, on any day after the Order has come into operation smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals, fluidised char binderless briquettes manufactured by the National Coal Board and "Multiheat"

briquettes having anthracite as a main constituent which have been subjected to a mild heat treatment process, and manufactured by the National Coal Board.

- 3. The Order will come into operation on the First day of July Nineteen Hundred and Sixty-eight or on such later date as is not earlier than six months from the date of the confirmation of the Order by the Secretary of State for Scotland.
- 4. Copies of the Order and of the Map referred to therein may be inspected free of charge at the Town Clerk's Office, Municipal Buildings, Falkirk at all reasonable times during the period of six weeks from the Fourth day of November Nineteen Hundred and Sixty-seven.
- 5. Within the said period any person who may be affected by the Order may by notice in writing to the Secretary, Scottish Development Department, St. Andrew's House, Edinburgh 1, object to the confirmation of the Order.
- 6. In order to qualify for grant for adaptation of a fireplace, expenditure must be incurred to the satisfaction of the said Burgh either (i) by the owner or occupier or other interested person after confirmation of the Order with the approval of the said Burgh, and incurred before the Order comes into operation or (ii) by the owner or occupier required by a notice under Section 12(2) of the said Act served at any time after the confirmation of the Order.
