PRICES AND INCOMES ACT 1966

Instruction under Section 3(2) to the National Board for Prices and Incomes

PAY OF UNIVERSITY TEACHERS IN GREAT BRITAIN

THE last full review of the remuneration of the academic staff of universities in Great Britain was undertaken in 1963/64 by the National Incomes Commission. Since that time the procedure has reverted to the arrangement under which increases are awarded directly by the Government after consultation with the University Grants Committee, which in turn is responsible for consulting the Committee of Vice-Chancellors and Principals and the Association of University Teachers.

2. It has been agreed between the parties concerned that the present machinery for the review of the remuneration of these academic staffs is unsatisfactory and the Government have reached the conclusion that the responsibility for reviewing this remuneration should be undertaken by the National Board for Prices and Incomes. For this purpose,

the Secretary of State for Economic Affairs has made an Order (The Prices and Incomes (Continuous Review) (No. 1) Order 1967 S.I. 1967/1581) under Section 3(1) of the Prices and Incomes Act 1966.

3. Accordingly, by virtue of that Order and in pursuance of their powers under Section 3(2) of the said Act, the Secretary of State for Economic Affairs and the Secretary of State for Education and Science, acting jointly, hereby instruct the National Board for Prices and Incomes to keep under continuous review the remuneration of the academic staff of universities in Great Britain.

PRICES AND INCOMES ACT 1966

Instruction under Section 3(2) to the National Board for Prices and Incomes

PAY OF THE ARMED FORCES

THE pay of the Armed Forces was last reviewed in 1966 when, following the recommendations of the National Board for Prices and Incomes (Report No. 10, Command 2881) the Government decided to implement pay increases with effect from 1st April 1966 in accordance with the two-yearly review procedure, based on generalised comparisons with movements of pay in certain civilian occupations, which had been operative since 1958. The next review under that procedure would have been due to take effect from 1st April 1968. The Government now consider it desirable that a continuous review of the pay and allowances of the Armed Forces should be undertaken by the National Board for Prices and Incomes. For this purpose the Secretary of State for Economic Affairs has made an Order (The Prices and Incomes (Continuous Review) (No. 1) Order 1967, S.I. 1967/1581) under Section 3(1) of the Prices and Incomes Act 1966.

2. Accordingly, by virtue of that Order and in pursuance of their powers under Section 3(2) of the said Act, the Secretary of State for Economic Affairs, the Chancellor of the Exchequer and the Secretary of State for Defence, acting jointly, hereby instruct the National Board for Prices and Incomes to keep under continuous review the pay and allowances of members of naval, military or air forces of the Crown and of any women's service administered by the Defence Council.

Amendment of Waiting Restrictions

TRUNK ROAD (ROUTE A.7) IN HAWICK

THE Secretary of State hereby gives notice that he proposes to make an order under sections 1 and 3 of the Road Traffic Regulation Act 1967 the effect of which is set out in the Schedule hereto.

SCHEDULE

The effect of the order would be to revoke the Trunk Roads (Various Streets, Hawick) (Prohibition of Waiting) Order 1965, which prohibits waiting and imposes alternating unilateral restrictions on the trunk road (route A.7) in Hawick between the hours of 10 a.m. and 6 p.m. Mondays to Saturdays inclusive, and to impose during the same hours and days the following amended restrictions:

- (a) Waiting would be limited to 30 minutes in any hour:
 - (i) on the west side from the junction with Laidlaw Terrace to the junction with Oliver Crescent and from a point 15 yards south of the junction with Oliver Crescent to a point 20 yards west of the junction with Tower Dykeside ;
 - (ii) on the north side from a point 47 yards west of the junction with Sandbed to the junction with Buccleuch Place ; and
 - (iii) on the south side from a point 6 yards west of the junction with Tower Dykeside westwards for a distance of 38 yards.
- (b) Waiting would be prohibited with no loading or unloading from 12 noon to 2.30 p.m. and 4.30 p.m. to 6 p.m.:
 - (i) on the east side from the junction with Duke Street to a point 6 yards west of the junction with Tower Dykeside ;
 - (ii) on the south side from a point 44 yards west of the junction with Tower Dykeside to the junction with Buccleuch Place ;
 - (iii) on the west side from the junction with Oliver Crescent southwards for a distance of 15 yards ; and
 - (iv) on the north side from a point 20 yards west of the junction with Tower Dykeside to a point 47 yards west of the junction with Sandbed.

The order will provide for exceptions to enable a vehicle to wait for as long as may be necessary for a person to board or alight, to enable goods to be loaded or unloaded (except from 12 noon to 2.30 p.m. and 4.30 p.m. to 6 p.m. on the lengths of road specified in sub-paragraph (b) above) and to be used in connection with maintenance operations and other works.

Extension of 30 m.p.h. Speed Limit

TRUNK ROAD A.9 AT HELMSDALE

CLEAN AIR ACT, 1956

The County of Clackmannan (Tullibody) Smoke Control Area Order, 1967

1. NOTICE is hereby given that the County Council of Clackmannan in exercise of the powers conferred on them by Section 11 of the above-mentioned Act on the Twenty-fifth day of October 1967, made an Order entitled The County of Clackmannan (Tullibody) Smoke Control Area Order, 1967, declaring the area described in the schedule hereto to be a Smoke Control Area. This Order is about to be submitted to the Secretary of State for Scotland for Confirmation and, if confirmed, will come into operation on the 1st day of November 1968.

2. Subject to the exemptions provided by the Order and by virtue of Section 11(4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels, low volatile steam coals and fluidised char binderless briquettes manufactured by the National Coal Board.

3. Copies of the Order and of the map referred to therein may be inspected free of charge at the office of The County Clerk, County Buildings, Alloa, at all reasonable times during the period of six weeks from the 10th day of November 1967.

4. Within the said period any person who will be affected by the Order may by Notice in writing to the Secretary, Scottish Development Department, St. Andrew's House, Edinburgh 1, object to the confirmation of the Order.
