ERSKINE BRIDGE (SOUTHERN APPROACHES)

- (a) to provide for six special roads in the County of Renfrew on the routes prescribed by the scheme, for the exclusive use of traffic of Classes I and II set out in Schedule 2 to the said Act, as varied by the Special Roads (Classes of Traffic) (Scotland) Order 1964; two of which special roads are to connect the trunk roads to be provided under the Erskine Bridge Trunk Roads (No. 2) Order 1967 with the Erskine Bridge Special Road, and the remaining four of which special roads are to connect the said special road with the Bishopton Bypass (Stage I) Special Road to be provided under the Bishopton Bypass (Stage I) Special Road Scheme 1967; and
