

Whereas the territories in Arabia known as the Protectorate of South Arabia are under Our protection:

And Whereas by treaty, grant, usage, sufferance and other lawful means We have power and jurisdiction in the Protectorate of South Arabia:

And Whereas it is intended that the territories known as the Protectorate of South Arabia shall become independent on the thirtieth day of November 1967 (hereinafter referred to as "the appointed day"):

Now, therefore, We do hereby, by and with the advice of Our Privy Council, proclaim and declare that, as from the beginning of the appointed day, Our protection over the territories known as the Protectorate of South Arabia and all functions, powers, rights, authority or jurisdiction exercisable by Us immediately before that day in or in relation to the said territories by treaty, grant, usage, sufferance or otherwise shall lapse.

Given at Our Court at Buckingham Palace, this twenty-eighth day of November, in the year of our Lord one thousand nine hundred and sixty-seven, and in the Sixteenth year of Our Reign.

Now, therefore, We do hereby, by and with the advice of Our Privy Council, proclaim and declare that, as from the beginning of the appointed day, all Our functions, powers, rights, authority or jurisdiction exercisable by Us immediately before that day in or in relation to Kamaran by usage, sufferance or otherwise shall lapse.

Given at Our Court at Buckingham Palace, this twenty-eighth day of November, in the year of our Lord one thousand nine hundred and sixty-seven, and in the Sixteenth year of Our Reign.

Viz.: The Import Duties (Process) (No. 1) Order 1967.

This Order made under section 8(5) of the Import Duties Act 1958 revokes the Import Duties (Process) (No. 2) Order 1965 and provides that woven fabric containing more than 90 per cent. by weight of man-made fibres sent abroad in order to be processed by dipping in a solution of latex and resorcinol formaldehyde resin will be chargeable on its return with customs duty in respect of the increased value attributable to the process only.

The Order comes into operation on 7th December 1967 and has been published as Statutory Instruments 1967 No. 1751.

# PRICES AND INCOMES ACT 1966

# Report of the National Board for Prices and Incomes THE REMUNERATION OF MILK DISTRIBUTORS (FINAL REPORT)

ON 13th January 1967, in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State, the Secretary of State for Scotland and the Minister of Agriculture, Fisheries and Food referred the question of the Remuneration of Milk Distributors to the National Board for Prices and Incomes for examination.

The Board has now made its final report and in accordance with section 5(1) of the Prices and Incomes Act 1966 the Secretary of State for Economic Affairs, the Secretary of State for Scotland and the Minister of Agriculture, Fisheries and Food hereby give notice that the report was first published as Command Paper Number 3477 on 28th November 1967. IN pursuance of section 180 of, and the Fourth Schedule to the Factories Act 1961, the Minister of Labour hereby gives notice that he proposes to make special regulations imposing requirements for the protection of persons employed in factories and other places where the Factories Act 1961 applies against ionising radiations arising from unsealed radioactive substances and from objects contaminated with radioactive substances. These regulations will revoke the Factories (Luminising) Special Regulations 1947.



# The Foot-and-Mouth Disease (Controlled Areas Restrictions) (Amendment) Order 1967

In a foot-and-mouth disease Controlled Areas, cattle, sheep, goats, pigs and deer may not be moved without a licence from an inspector of a local authority. This order, which came into operation on 22nd November 1967, prevents unsold animals in a fatstock market, fair or sale, or in a certification centre, from being licensed to be moved back to premises from which they were brought; a licence may now only authorise their removal direct to a slaughterhouse.

The effects of the Order will be to introduce.

- 1. A ban on all waiting (including waiting for the purpose of loading or unloading goods) so as to provide "Clearway" conditions on the main radial routes described in Appendix I hereof, between 8 a.m. and 9.30 a.m. and between 4 p.m. and 6.30 p.m. from Mondays to Fridays inclusive;
- 2. "No Waiting" restrictions between 8 a.m. and 1 p.m. on Saturdays and between 8 a.m. and 6.30 p.m. from Mondays to Fridays inclusive and a ban on waiting for the purpose of loading or unloading goods between 8 a.m. and 9.30 a.m. from Mondays to Saturdays inclusive and between 4 p.m. and 6.30 p.m. from Mondays to Fridays inclusive over a distance of 140 feet on both the approach and exit sides of the controlled road junctions described in Appendix II hereof;
- 3. Limited waiting for a period not exceeding 30 minutes between 9.30 a.m. and 1 p.m. on Saturdays and between 9.30 a.m. and 4 p.m. from Mondays to Fridays inclusive on those sections of the radial routes which pass through shopping areas (on which there are no restrictions at present), the said streets being described in Appendix III hereof;
- 4. An express prohibition on double banking on all radial routes specified in the said Appendix I; and
- 5. "Bus bays" at certain bus stops on the radial routes at which all waiting, loading and unloading would be prohibited between the hours of 6 a.m. and 12 midnight daily.
