## GENERAL POST OFFICE

### WIRELESS TELEGRAPHY ACT 1949

THE Postmaster General hereby gives notice to all holders of "Broadcast Receiving Licences (Including Television)—General Form" (under paragraph 7 of the Schedule thereto), to all holders of "Broadcast Receiving Licences (Including Television)—Multiple form" (under paragraph 7 of the First Schedule thereto) and to all holders of "Broadcast Receiving Licences (including Television)—Hotels Comprehensive form" (under paragraph 7 of the First Schedule thereto) that on and from the 8th February 1968 the terms of the said Licences are hereby varied as follows:

(1) Clause 1(b) thereof shall be varied so as to read as follows:

"to use the said apparatus for the purposes of receiving

(i) visual images sent by television which can be exhibited by the said apparatus in monochrome only and messages sent by telephony from authorised Broadcasting Stations for general reception, and

(ii) visual images sent by television which can be exhibited by the said apparatus in monochrome only and messages sent by telephony or telegraphy from licensed amateur stations."

(2) The following clause shall be added at the end thereof:  
"This licence does not authorise the use of any apparatus for the purpose of receiving visual images sent by television which can be exhibited by the apparatus otherwise than in monochrome."

Note.—A fresh licence is required authorising the reception of television in colour.

DISEASES OF ANIMALS ACT 1950

NOTICE is hereby given in pursuance of Section 85(3) of the Diseases of Animals Act, 1950 that the Minister of Agriculture, Fisheries and Food has made the following Order:

(Statutory Instruments 1968 No. 51)

*The Foot-and-Mouth Disease (Controlled Areas  
Restrictions) (Amendment) Order 1968*

This Order permits the holding of markets, fairs or sales of animals not intended for immediate slaughter within a Controlled Area for foot-and-mouth disease, subject to licensing by the Local Authority and the consent of the Minister. After such a market, unsold animals can only be licensed to be moved either to the premises from which they were brought to the market or direct to a slaughterhouse.

(Statutory Instruments 1968 No. 94)

*The Foot-and-Mouth Disease (Imported Meat) Order 1968*

This Order prohibits the removal from store of all fresh or refrigerated meat or offal of carcasses of animals landed in Great Britain other than from countries scheduled to the order—except in accordance with a licence issued by the Minister of Agriculture, Fisheries and Food or the Secretary of State for Scotland.
