2. To prohibit waiting at all times (except for vehicles loading or unloading) in the following portions of streets:

From Princes Street to Huntly Place junction.

3. To prohibit waiting between the hours of 8 a.m. and 6 p.m. (except for vehicles loading or unloading) in the following portions of streets:

CHURCH STREET

- (a) Both sides from Princes Street to King Street.
- (b) North west side from King Street to Falconer Street.

FORE STREET

North East side, from junction of access road to Glasgow Road to east side of John Wood Street junction.

4. To restrict waiting to 30 minutes in any hour between 8 a.m. and 6 p.m. (except for vehicles loading or unloading) in the following street and portions of streets:

BALFOUR STREET

West side.

JOHN WOOD STREET

Whole Street.

North East side.
