## PRICES AND INCOMES ACTS 1966 AND 1967

*Reference to the National Board for Prices and Incomes of Agreements relating to terms and conditions of employment of draughtsmen in certain companies in the engineering industry and notice of a direction in relation thereto under section 15 of the Prices and Incomes Act 1966 and section 2 of the Prices and Incomes Act 1967*

THE Secretary of State for Economic Affairs and the Minister of Labour (hereinafter referred to as "the said Ministers"), acting jointly in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, hereby refer to the National Board for Prices and Incomes for their report the following settlements, that is to say:

- (a) the Agreement made on 5th December 1967 between Steels Engineering Installations Limited and the Draughtsmen's and Allied Technicians' Association providing for increases in the rates of pay of:
  - (i) weekly paid drawing office apprentices and adult draughtsmen; and
  - (ii) monthly paid draughtsmen;
- (b) the Agreement made on 5th December 1967 between Steels Process Plants Limited and the Draughtsmen's and Allied Technicians' Association providing for increases in the rates of pay of:
  - (i) weekly paid drawing office apprentices and adult draughtsmen; and
  - (ii) monthly paid draughtsmen;
- (c) the Agreement made on 5th December 1967 between British Crane & Excavator Corporation Limited and the Draughtsmen's and Allied Technicians' Association providing for increases in the rates of pay of:
  - (i) weekly paid draughtswomen up to and including the age of 20 years;
  - (ii) weekly paid male and female members of the Draughtsmen's and Allied Technicians' Association and weekly paid apprentices; and
  - (iii) monthly paid members of the Draughtsmen's and Allied Technicians' Association; and

- (d) the Agreement made on or about 7th September 1967 between Beckman Instruments Limited and the Draughtsmen's and Allied Technicians' Association providing for increases in the rates of pay of draughtsmen and tracers.

By virtue of the aforesaid references the said Ministers acting jointly in pursuance of their powers under section 15(1) of the Prices and Incomes Act, 1966, as extended by section 2 of the Prices and Incomes Act, 1967, hereby direct that the said section 15 shall apply:

- (1) to the Agreements specified in paragraphs (a) (b) and (c) above by reference to 5th December 1967.
- (2) to the Agreement specified in paragraph (d) above by reference to 30th November 1967.

This Direction shall come into force on 24th February 1968.

### Note:

This reference was notified in the London Gazette on 20th February, 1968 and takes effect on that date.

The direction that section 15 of the Prices and Incomes Act 1966 shall apply results in standstills on the implementation of the Agreements referred to in the direction until the publication (not later than three months from the said date) of the Board's report on the reference.

The standstills come into force on 24th February 1968, and in the case of the Agreements specified in paragraphs (a), (b) and (c) above apply by reference back to 5th December 1967 which is the date on which the Agreements were made and in the case of the Agreement specified in paragraph (d) above by reference back to 30th November 1967 which precedes the implementation of that Agreement.

It should also be noted that, by virtue of section 1 of the Prices and Incomes Act, 1967, the standstills in respect of any of the Agreements may continue beyond the publication of the Board's Report if it should contain a recommendation adverse in any respect to the implementation of that Agreement.

## BOX JUNCTION ROAD MARKINGS

## SCHEDULE

The order prohibits the driving of a vehicle into a "boxed area," indicated by yellow cross-hatched lines in the form of a box laid on the carriageway at the junction of trunk road A.78 with route A.736 (Fullarton Street and Fullarton Place) in Irvine, and then driving it so that it becomes necessary, because of stationary vehicles, for any part of the vehicle to remain at rest within the "boxed area."

The order contains exceptions to enable a vehicle to stop in the "boxed area" for so long as necessary to enable the vehicle to make a right turn, to enable the vehicle to be used in connection with police, fire brigade, ambulance or civil defence purposes, and to enable a vehicle to stop without the driver being guilty of an offence if, when he drove into the area, he had reasonable cause to believe that he would immediately be able to drive the vehicle out of the area.

## SCHEDULE

The effect of the order is to impose the following additional waiting restrictions on the trunk road in Fort William.

Waiting is prohibited at any time and loading is prohibited between the hours of 10 a.m. and 8 p.m. on the south-east side of the trunk road from Bank Street in a south-westerly direction for 35 yards.

The order provides for exceptions to enable a vehicle to wait for as long as necessary for a person to board or alight, to load and unload (outwith the prohibited hours) and to be used in connection with maintenance operations and other works.

NOTICE is hereby given that the following byelaw has been made and confirmed by the Secretary of State for Scotland:

## SEA FISHERIES

The Sea Fisheries (Scotland) Byelaw (No. 78) 1967

Made 19th September, 1967

Coming into operation 19th September, 1968

The Secretary of State in exercise of the powers conferred upon him by section 6 of the Herring Fishery (Scotland) Act 1889(a), and of all other powers enabling him in that behalf, hereby makes the following Byelaw:

## Citation, commencement and interpretation

1. (1) This Byelaw may be cited as the Sea Fisheries (Scotland) Byelaw (No. 78) 1967.

(2) This Byelaw shall come into operation on the date of its confirmation by the Secretary of State.

(3) The Interpretation Act 1889(b) shall apply for the interpretation of this Byelaw as it applies for the interpretation of an Act of Parliament.

## Revocation of Byelaw (No. 74) 1965

2. The Sea Fisheries (Scotland) Byelaw (No. 74) 1965 (c) is hereby revoked.

## Method of fishing permitted in a defined area of the Firth of Forth

3. It shall be lawful to use the method of fishing known as otter trawling within the following areas of the Firth of Forth:

(a) that area bounded on the north and south by the shores of the Firth; on the west by straight lines drawn from Kincaid Point to Inchkeith Lighthouse and thence to the end of the East Pier of Fishermans Harbour; and on the east by straight lines drawn from Fife Ness to the Isle of May Lighthouse and thence to Tantallon Castle;

(b) the area lying within 3 miles of low water mark of any part of the coast of the Isle of May;

(which areas are hereinafter referred to as 'the defined area') subject to the following conditions:

(a) such method of fishing shall be so lawful during the period from the date of coming into operation of this Byelaw until 5th July, 1968 and for the purpose of capturing nephrops norvegicus;

(b) any boat from which such method of fishing is used within the defined area shall not exceed 55 feet in length overall;

(c) the number of otter boards used on any occasion in such method of fishing within the defined area shall not exceed 2;

(d) any otter board so used shall not exceed 1 inch in thickness and shall be of such other dimensions that if placed on a level surface with the towing bracket upwards the product of the maximum length and the maximum breadth of the surface so covered shall not exceed 16 square feet;

(e) the surface of the cross-section of any metal keel or shoe forming part of any otter board so used shall not exceed 3 square inches;

(f) it shall not be lawful for any boat carrying any otter board which does not comply with the provisions of the foregoing conditions (d) and (e) to be engaged in using such method of fishing within the defined area;

(g) no landing at the termination of a voyage by a boat which has been engaged in such method of fishing within



the defined area at any time during such voyage shall contain more than 25 per centum by weight of fish other than *nephrops norvegicus*.

Fishery Byelaw for Moray Firth

NOTICE is hereby given that the following beylaw has been made and confirmed by the Secretary of State for Scotland:

SEA FISHERIES

The Sea Fisheries (Scotland) Byelaw (No. 77) 1967  
Made 19th September, 1967

Coming into Operation 19th February, 1968

The Secretary of State in exercise of the powers conferred on him by sections 6 and 7 of the Herring Fishery (Scotland) Act 1889(a), and of all other powers enabling him in that behalf, hereby makes the following Byelaw:

Citation, commencement and interpretation

1. (1) This Bylaw may be cited as the Sea Fisheries (Scotland) Byelaw (No. 77) 1967.
- (2) This Bylaw shall come into operation on the date of its confirmation by the Secretary of State.
- (3) The interpretation Act 1889(b) shall apply for the interpretation of this Byelaw as it applies for the interpretation of an Act of Parliament.

Revocation of Byelaw (No. 73) 1965

2. The Sea Fisheries (Scotland) Byelaw (No. 73) 1965(c) is hereby revoked.

Method of fishing permitted in a defined area of the Moray Firth

3. Notwithstanding the provisions of Byelaw (No. 10) made by the Fishery Board for Scotland on 27th September, 1892 and confirmed by the Secretary of State for Scotland on 22nd November, 1892(d) it shall be lawful to use the method of fishing known as otter trawling in that area of the Moray Firth lying south of a line drawn due east (true) from Brora point except those parts thereof lying (i) within 3 miles of low water mark of any part of the coast between Brora Point and Rattray Head, or (ii) to the westward of a straight line joining Brora Point and Tarbet Ness Lighthouse (which area is hereinafter referred to as "the defined area") subject to the following conditions:
- (a) such method of fishing shall be so lawful during the periods from the date of coming into operation of this Byelaw until 31st October, 1967 and from 1st April, 1968 until 5th July, 1968 and for the purpose of capturing *nephrops norvegicus* ;
- (b) any boat from which such method of fishing is used within the defined area shall not exceed 70 feet in length overall ;
- (c) the number of otter boards used on any occasion in such method of fishing shall not exceed 2 ;
- (d) any otter board used shall not exceed 1½ inches in thickness and shall be of such other dimensions that if placed on a level surface with the towing bracket upwards the product of the maximum length and the maximum breadth of the surface so covered shall not exceed 16 square feet.
- (e) the surface area of the cross-section of any metal keel or shoe forming part of any otter board so used shall not exceed 4½ square inches ;
- (f) it shall not be lawful for any boat carrying any otter board which does not comply with the provisions of the foregoing conditions (d) and (e) to be engaged in using such methods of fishing within the defined area ;
- (g) no landing at the termination of a voyage by a boat which has been engaged in such method of fishing within the defined area at any time during such voyage

shall contain no more than 25 per centum by weight of fish other than *nephrops norvegicus*.

NORTH OF SCOTLAND HYDRO-ELECTRIC  
BOARD

Constructional Scheme No. 40  
FOYERS PROJECT

THE North of Scotland Hydro-Electric Board have prepared a Constructional Scheme in accordance with Section 5 of the Hydro-Electric Development (Scotland) Act, 1943, as amended by the Electricity Act, 1947 and by the Electricity Re-organisation (Scotland) Act, 1954, providing for the construction of Works, the situations of which are shown in Part I of the Schedule hereto and for the acquisition of the lands specified in Part II of the said Schedule.

The Scheme has been submitted to the Secretary of State for confirmation.

SCHEDULE  
Part I—Works

In the County of Inverness—

- Work No. 1—A reservoir (comprising the existing reservoir of Loch Mhor), partly in the Parish of Boleskine and Abertarff, partly in the Parish of Dores and partly in the Parish of Daviot and Dunlichity, to be formed by the renovation of the three existing dams at the south-western end of Loch Mhor, and including dredging in the bed of Loch Mhor and work on the causeway crossing Loch Mhor.
- Work No. 2—An aqueduct, line or lines of pipes, in the Parish of Boleskine and Abertarff, commencing at or in the south-western end of the reservoir (Work No. 1) and terminating at or in Loch Ness at a point 1,400 yards or thereby

measured in a north-easterly direction from the out-let of the River Foyers.

- Work No. 3—A generating and pumping station, in the Parish of Boleskine and Abertarff, situated at the termination of the aqueduct (Work No. 2) and including a tailrace into Loch Ness.
- Work No. 4—A diversion in the Parish of Boleskine and Abertarff of the public road from White Bridge to Errogie between a point 1,500 yards or thereby measured in a north-easterly direction from the most northerly of the said three dams and a point 2,000 yards or thereby measured in a north-easterly direction from that dam.
- Work No. 5—An aqueduct, line or lines of pipes, in the Parish of Boleskine and Abertarff, commencing on the Allt Breinag at a point 1,600 yards or thereby measured in a south-westerly direction from White Bridge and terminating in the south-western end of the reservoir (Work No. 1).
